If you are recommended for a parole grant/release, the time frame within which you shall be released, as established by the Chairperson of the Parole Commission, shall be reflected in the grant/order.

GENERAL REASONS FOR ACTION TAKEN

1. You have developed an adequate plan, but will need Agent's verification.
2. Your institutional conduct has been satisfactory.
3. Your program participation has been satisfactory.
4. Release at this time would involve an unreasonable risk to the public.
5. You have NOT served sufficient time for punishment.

COMMISSION COMMENTS

You are currently serving time on your fifth incarceration (third in Wisconsin). Your sentence structure is comprised of two parole revocations and two new sentences. The total time of your sentence structure is 66 years, 8 months, and 15 days. Crimes covered under this structure include three counts of Forgery-Uttering and one count of Armed Robbery. You have now served 18 years, 5 months, and 1 day towards this sentence. As of today, your mandatory release date is 10/07/42 and your parole eligibility date is 08/08/14. PMR applies to the Armed Robbery case and was discussed today. The Armed Robbery involved you and your accomplices robbing a bank while armed. The other offenses involved you forging and cashing bad checks. You were last released from the institution on 03/13/95 via a parole grant from TCC. Less than a year later you were back in custody facing new criminal charges. Your criminal record includes other convictions for Armed Robbery and Robbery out of Illinois. Since returning to the institution you have received a total of 8 minor and 2 major conduct reports. The most recent major conduct report occurred in 2012 when you were involved in a fight with another inmate. This was addressed at your last parole review and you have not received any conduct reports since then. In regards to treatment, all needs have been met. You have completed AODA-Level 3, AODA-Level 6, and Anger Management. You also completed vocational programming in 2011. Upon release you would like to reside with your wife in Racine. That plan will require agent approval prior to release. Based on all factors, including today's review, the Parole Commission has decided to defer you for a period of 12 months. More time is warranted to be served given the serious nature of your offenses. You have a lengthy prior record without much success in the community on supervision. You also received the maximum sentence on the Armed Robbery conviction. Therefore you must continue to work to show you are serious about reducing your risk and returning to the community in a positive fashion. This success must be demonstrated over a protracted period of time to show you are ready for life in the community given the factors mentioned.
