

Dear Mr. Hubanks:

I'm writing with an update on our investigation in your case. Keith, Chris, Mario, and I met today. We discussed the statement Aaron Evans gave to Chris and Mike Hutton last summer. We think the statement may be significant, but we think we need to try to corroborate it. We are going to seek the following kinds of corroboration: 1) we will review the case documents for evidence that the car involved in the crime did have tires in it before Reggie Larkin had possession of it, but did not have tires in it after you were arrested. This could be significant corroborating evidence that Evans is telling the truth; 2) We will be contacting your cousin, Earl, so see if he has any further ideas about how to find Old Man Grady or anyone else who might be able to corroborate Evans's story.


Dear Mr. Hubanks:
