I RECENTLY RECEIVED A COPY OF THE ARTICLE YOU WROTE LAST YEAR AFTER A HEARING I HAD IN WOOD CNTY. CIRCUIT COURT. I NOTICED YOU WEREN'T THERE FOR THE OCT. 20TH HEARING - WHICH HAD BEEN RESCHEDULED AT LEAST ONCE. ALSO, THE COURT ROOM DOORS WERE CLOSED, WHICH I'D NEVER SEEN BEFORE.

I'M NOT SEEKING MEDIA ATTENTION BY WRITING YOU - I'M JUST WONDERING IF YOU WERE EXCLUDED BY DESIGN, OR CHOSE NOT TO BE THERE? ENCLOSED ARE A FEW ITEMS I'VE FILED, OR I AM DRAFTING.

IF THE POLICE DIDN'T FABRICATE THE EVIDENCE, HOW DO THEY EXPLAIN THE SHOES? THIS MOTION TO SUPPLEMENT" IS A DRAFT I AM WORKING ON - PLEASE KEEP THIS TO YOURSELF. I DID ROBE THIS

ISSUE TO THE COURT DURING THE OCT. 20TH HEARING,
SO IT'S NOT SECRET - I JUST ASK YOU TO KEEP THE
DOCUMENT TO YOURSELF.

I'VE ATTEMPTED TO SET FORTH THE FALSE FBI
DNA TESTIMONY TO THE JUDGE IN THE LETTER DATED
12-3-15. THERE ARE SEVERAL OTHER ISSUES NOT
COVERED BY THESE DOCUMENTS.

1. THE POLICE FABRICATED THIS EVIDENCE;
2. THE FBI GAVE FALSE TESTIMONY ON DNA;
3. THE STATE COACHED WITNESSES.

DAVE FISCHER LIVES IN WEST BEND, BRENT FROST 262-
251-6766, CYNTHIA EMERICH TOLD ME THE STATE WAS
COACHING WITNESSES AS THEY CALLED THEM TO TESTIFY,
AND OTHER STUFF.

THEY DESTROYED THE EVIDENCE TO COVER UP.
THEY ARE NOW DENYING ME ACCESS TO EVIDENCE
FOR TESTING IN ORDER TO CONTINUE TO COVER. IF
YOU HAVE NOTHING TO HIDE - WHY WOULD YOU FIGHT
TESTING?

25 YRS AGO DNA WAS BRAND NEW. I DON'T
BELIEVE IT HAD BEEN USED IN OUR AREA AT ALL -
BEYOND PATERNITY TESTING, WHICH IS SOMEWHAT
DIFFERENT. MY LAWYER CERTAINLY WASN'T PREPARED TO
TRY THIS ISSUE.

HOW CAN ONE TEST ALLEGEDLY MATCHING ON 3
PROBES BE INCONCLUSIVE, YET OTHER TESTS ALLEGEDLY
MATCHING ON 2-3 PROBES BE DECLARED A "MATCH"?

IT DEPENDS UPON WHAT RESULTS WERE USEFUL TO THE STATE.

WHAT WERE MY OPTIONS? TO CALL THE FBI, ETAL LIARS, OR TO ATTEMPT TO EXPLAIN AWAY EVIDENCE FABRICATED BY POLICE? MY LAWYER CHOSE THE LATER.

PEOPLE ARE "TRAINED" TO BELIEVE THAT ALTHOUGH THEY MAY NOT UNDERSTAND DNA, ONCE THEY CLAIM TO HAVE IT - ITS OVER. AND THE FBI ALWAYS PRESENTS ITSELF AS THE LARGEST, MOST EFFICIENT LAW ENFORCEMENT AGENCY IN THE WORLD, THEY ALWAYS GET THEIR MAN. THAT THEY HAVE ALL THE RESOURCES AND THE UTMOST INTEGRITY, ETC.

KEEPING IN MIND THAT ALL OF THE DNA TEST RESULTS WERE PREVIOUSLY DECLARED INCONCLUSIVE, HOW IS IT THEY COULD TESTIFY TO A "MATCH" ON ANY RESULT?

THE POLICE HAD ALL OF THIS EVIDENCE AT THE POLICE STATION FOR 2 WKS BEFORE TAKING IT TO THE CRIME LAB. ONE COP TOOK ALL OF THE

EVIDENCE TO THIS CRIME LAB - EXCEPT THE SHOES. THE
COP WHO DESTROYED THE EVIDENCE TOOK THE SHOES
BY HIMSELF. NOT ONE REPORT OR TRANSCRIPT
LISTED THE SHOE SIZE. NOW I FIND OUT -
BY ACCIDENT - THE SHOES ARE TOO SMALL TO EVEN
GET MY FEET INTO.

HAD MY LAWYER KNOWN THESE THINGS AS TRIAL -
REASONABLE DOUBT COULD EASILY HAVE BEEN CREATED.
THE PERSON THE POLICE SHOULD'VE BEEN LOOKING FOR
OBVIOUSLY WORE SIZE 9 1/2 SHOES AND IS PGM TYPE 1.

I'VE SPENT 25 YRS IN MAXIMUM SECURITY
PRISON NOW, (NEARLY), ON FALSE FBI TESTIMONY,
FABRICATED EVIDENCE, COERCED WITNESSES, OTHER
EXPERTS CHANGING TESTIMONY, AND OTHER ISSUES.

THEN, DURING THE OCT. 20TH HEARING, THE
STATE FIGHTS TESTING THE REMAINING EVIDENCE
AND USES ~~THE~~ A COP AS AN EXPERT ON DNA.
THE JUDGE TOLD ME NOT TO SPEAK, SO I
WASN'T EVEN ALLOWED TO OBJECT.

25 YRS, NO EDUCATION, NO LAWYER, NO RESOURCES, I
HAVE NO PHONE, PHONE BOOK, ACCESS TO CONSULT WITH

OF 4-20-15, NO RESPONSE. BECAUSE THE POLICE
DESTROYED THE DNA EVIDENCE - THE F.W. PROJ.
WON'T EVEN DISCUSS THESE ISSUES WITH ME.

WHILE THE FBI CLAIM TO BE SEEKING
CASES TO REVIEW - NO ONE IS TRYING TO

TO REVIEW THEM. I BELIEVE IF THEY DID, IT'D
OPEN UP EVERY DNA CASE TO REVIEW, NOT JUST
THOSE ON HATE CASES, AND THEY DON'T WANT THAT.
BUT - COULD THEY EVEN BE TRUSTED TO GIVE
A FAIR REVIEW? I BELIEVE IT ISN'T EVEN
NECESSARY. I'VE POINTED OUT SEVERAL ISSUES, AND
IF I EXPLAINED IT CLEARLY ENOUGH - AN EXPERT
REVIEW SHOULDN'T BE REQUIRED, BUT WHAT DO
I KNOW? THEY WON'T EVEN SPEAK TO ME WITHOUT A LAWYER.

MY LAWYER DIDN'T RETEST THE DNA. HE
HAD A LAB REVIEW FBI NOTES, ETC... BUT NOT
THEIR TESTIMONY. HAD MY LAWYER SO MUCH AS
POINTED OUT THE FALSE FBI TESTIMONY AND THE FACT
THAT THE SHOES WEREN'T THE RIGHT SIZE - WOULDN'T
FIT - IT WOULD'VE CERTAINLY CHANGED THE STRIP'S
OPINION.

I HAVE A DRAFT OF A REPLY BRIEF I AM
WORKING ON ALSO, IF YOU'RE INTERESTED. IF YOU
WERE EXCLUDED FROM THIS LAST HEARING SO THE
STATE COULD CONTINUE TO COVER UP ALL OF THIS -
