RE: "Hunger strike"

DEAR MS. SWAN:

This is a call for all prisoners in Restraining Housing Units (RHUs), Administrative confinement and general population (G.P.), as well as the free oppressed and non-oppressed people to support this hunger strike in protest of the violation of our Civil [human rights, here in the state of Wisconsin.

It should be clear to everyone that none of the hunger strike participants want to die, but due to our circumstances, whereas the state of Wisconsin has sentenced all of us on indeterminate Rhu program to a "civil death" merely on the word of a prisoner snitch.

The purpose of the hunger strike is to combat both Administrative confinement and Rsh psychological and physical torture, as well as the justifications used of support treatment of the type that leads to prisoners being subjected to a civil

death. Those subjected to Rsh programs are neglected and deprived of the basic human necessities while withering away in a very isolated and hostile environment.

Prison officials have utilized the assassination of prisoners' character to each other as well as the general public in order to justify their inhumane treatment of prisoners. The "code of silence" used by guards allows them the freedom to use everything at their disposal in order to break those prisoners who prison officials believe cannot be broken.

This mentality has created the current atmosphere in which prison officials agreed upon plan to break Rsh prisoners. This pretracted attack on Rsh prisoners cuts across every aspect of the prisoner's function, isolation, cell searches, family and socio-culture, economic, and political deprivation. This is nothing short of the psychological and physical torture of Rsh and administrative confinement. It takes place day in and day out, without a break or rest.

Therefore, I will not come off my hunger strike until the Department of Corrections end solitary confinement and release inmates to general population who have been warehoused indefinitely in Rsh for the last 10 to 20 years.

MS. SWAN, I have been on my hunger strike since June 17, 2016, and all the laboratory tests performed on my urine has showed, blood, protein, ketones and dehydration and according to medical staff, I am moderate to severely malnourished and dehydrated.

I stopped drink all water because I believe that the drinking water has a high level of perchlorate in it.

I would like for you to contact LBCI and the Department of Corrections, making congressional inquiries about the hunger striking inmates at C.B.C.I.

I will also be providing you with information and documents on the mysterious death of inmate Flores that happened on July 4, 2016 at approximately 8:49 p.m.
