

Brief Summary:	Complains of statements made by Officer Kazik		
Summary of Facts:	Inmate Blue complains that Officer Kazik made comments to him such as "If I see you doing anything I'm going to fuck you over, I'm going to get you out of here". The inmate Blue was called to meet with the ICE and DAI Policy 310.00.01 was explained to him. During the meeting the provisions of DOC 303.32, Wis. Admin. Code, were reviewed. He was also informed that, because the investigation process is regulated by state law (which protects the privacy and due process rights of staff) no further information would be given him. The inmate chose to pursue the complaint and provided a detailed written description of the events he claimed happened. Based on that statement and the sensitive nature of this incident, it is recommended this complaint be dismissed and be further processed pursuant to DAI Policy 310.00.01. Consequently, no further action will be taken by this office.





Brief Summary:	Complains of Officer Holterman		
Rejection Comment:	Inmate Blue complains about Officer Holterman's actions noting that he harasses and uses methods of intimidation toward him. He states he even came to his cell and threatened him. The ICE may reject a complaint if the ICE determines the inmate does not allege sufficient facts upon which redress may be made. Any time you file staff complaints in the future, you will need to be more specific with your allegations. "Harassing and Intimidating" are not characteristic enough to conduct a thorough investigation. Make sure you use specific dates, times, and quotes. You state he threatened you but fail to provide a date or what the nature of his threat(s) were. Rejected pursuant to DOC 310.11(5)(c), Wis. Adm. Code, because the "inmate does not allege sufficient facts upon which redress may be made".



Summary of Facts:	Inmate Blue complains that Sgt. Wery made the comment "You should try keeping your dick in your pants" in front of several other inmates. Inmate Blue was provided with an explanation of DAI Policy 310.00.01. In addition to that, the provisions of DOC 303.32, Wis. Adm. Code, were also provided. He was also informed that, because the investigative process is regulated by state law (which protects the privacy and due process rights of staff) no further information would be given to him. Inmate Blue chose to pursue the complaint and provided statement indicating that his complaint outlined the events that occurred. Based on that statement and the sensitive nature of this incident, it is recommended this complaint be dismissed, with the modification that it be further processed pursuant to the applicable personnel rules and agreements pursuant to DAI Policy 310.00.01. Consequently, no further action will be taken by this office.
