

Detail updates for blog on my case and search for help.

- 1: There are wrongfully convicted people in prison convicted for crimes they did not commit as a result of gross police and prosecutor misconduct and deficient and neglectful attorney representation.
- 2: Of the long list of people who have been wrongfully convicted and only later to have been found innocent after serving two or three decades in prison for a crime they did not commit.
- 3: Well there exist an additional person that was added to that list of wrongful conviction 24 years ago, who presently remain in prison, and that person is Terry Jackson.
- 4: The picture I just showed you is Terry Jackson that I'm speaking of, who was wrongfully convicted and put in prison for a crime he not only did not commit, but attempted to stop who was responsible for committing the crime of murder.
- 5: On April 26, 1991 Darnell Williford a native of Racine, Wisconsin physically assaulted a individual by the name Christopher Berry by striking him and snatching some cocaine out of the hands of Christopher Berry and running with those drugs. Christopher Berry in return unleashed a Rottweiler dog to chase Darnell Williford while Christopher Berry begin attempting to load a sawed off pump shotgun while chasing Darnell Williford along with his dog. Christopher Berry attempted to load and shoot the shotgun at Darnell Williford, but the shot gun jammed preventing Christopher Berry from shooting Darnell Williford that day and allowing Darnell Williford to escape by running into a female house to secure himself from Christopher Berry dog and Christopher Berry attempts to shoot Darnell Williford

while Christopher Berry begin attempting to load a sawed off pump shotgun while chasing Darnell Williford along with his dog. Christopher Berry attempted to load and shoot the shotgun at Darnell Williford, but the shot gun jammed preventing Christopher Berry from shooting Darnell Williford that day and allowing Darnell Williford to escape by running into a female house to secure himself from Christopher Berry dog and Christopher Berry attempts to shoot Darnell Williford in retaliation for Darnell Williford striking him and snatching Christopher Berry drugs.

6. So with Darnell Williford being Terry Jackson friend, when Terry Jackson heard about Darnell Williford being chased By Christopher Berry, when Terry Jackson crossed paths with Christopher Berry, Mr. Jackson attempted to defuse the conflict between Christopher Berry and Darnell Williford by asking Christopher Berry

7. not to retaliate against Darnell Williford and asking Christopher Berry to allow him (Terry Jackson) to talk to Darnell Williford in attempt to convince Darnell Williford to give him his drugs back or attempt to convince Darnell to pay him back for the drugs he had taken from Christopher Berry and his group of friends;
8. Christopher Berry recognized that Terry Jackson was trying to bring about a peaceful solution to the conflict between Christopher Berry and Darnell Williford, so Christopher Berry agreed with Terry Jackson that he would stop chasing and looking for Darnell Williford to allow Mr. Jackson the opportunity to defuse the conflict between Christopher Berry and Darnell Williford;
9. With the pressures of Christopher Berry group of friends instigating for Christopher Berry to look for and retaliate against Darnell Williford for what he had done, Christopher Berry broke his word and agreement to no longer look for Darnell Williford, and went looking for Darnell Williford anyway by showing up at Darnell Williford girlfriend house with a Mexican male who had provided and supplied Christopher Berry the drugs in the first place;
10. Through the grapevine and rumors of this neighborhood Terry Jackson found out about the continuous search of Darnell Williford by Christopher Berry going to Darnell Williford girlfriend house which broke the agreement that Christopher Berry agreed to that he would no longer look for or chase Darnell Williford to allow Terry Jackson to try to bring a peaceful resolution to Christopher Berry and Darnell Williford conflict;
11. So, Christopher Berry breaking this agreement to discontinue looking for Darnell Williford suspended Terry Jackson decision to intervene to try to bring a peaceful solution to Christopher Berry and Darnell Williford conflict, because Terry Jackson knew that Christopher Berry showing up at Darnell Williford

girlfriend house only inflamed the conflict between Darnell Williford and Christopher Berry and likely diminished and severed any chance for a peaceful resolution between Darnell Williford and Christopher Berry. So at that point Terry Jackson withdrew any attempts to intervene between Christopher Berry and Darnell Williford conflict. It was even reported from Darnell Williford own Aunt that she couldn't even get Darnell Williford to give back the drugs he had taken from Christopher Berry even after she had plead with him to give the drugs back. She said Darnell Williford just ran from her.

12. On April 29, 1991 (three days later) Christopher Berry was approached by those who were instigating him into retaliating against Darnell Williford (according to Christopher Berry own statement to the police) and that person informed Christopher Berry that Darnell Williford was at the Dr. Martin Luther King Jr. community center playing basketball. This person told Christopher Berry it was his opportunity to confront Darnell Williford, and told Christopher Berry to come go up to the center and confront Darnell Williford for hitting him and taking his drugs.

13. Christopher Berry instead of going directly to the center to confront Darnell Williford, Christopher Berry opted to look for Terry Jackson at his house and afford Terry Jackson the chance to persuade and convince Darnell Williford to give back the drugs he had taken or agree to pay Christopher Berry back for the drugs Darnell Williford had taken.

14. Terry Jackson told Christopher Berry when he came to Terry Jackson house to ask him to go up to the Dr. King Jr. community center to try to persuade Darnell Williford to give Christopher Berry back the drugs or agree to pay him for the drugs Darnell Williford had taken. Terry Jackson at that point informed Christopher Berry that he (Terry Jackson) was made aware through the grapevine of the neighborhood, that Christopher Berry had went to Darnell Williford girlfriend house looking for Darnell Williford after he gave his word that he would no longer pursue or look

for Darnell Williford. So at that point Terry Jackson told Christopher Berry that he decline to intervene or mediate between Darnell Williford and Christopher Berry, because of Christopher Berry going to Darnell Williford girl friend house looking for Darnell Williford and increasing and escalating even more tension between Christopher Berry and Darnell Williford. So Terry Jackson told Christopher Berry as a result of Christopher Berry creating more tension between Darnell Williford and Christopher Berry, Terry Jackson therefore wasn't getting involved to try and mediate their conflict.

15. Terry Jackson telling Christopher Berry that he wasn't going up to the Dr. King center to mediate between Christopher Berry And Darnell Williford upset Christopher Berry, which at that point Christopher Berry. That's when Christopher Berry walked out the door stating these words, "fuck it, I'll just walk in the center and shoot him then" " I tried to give you the chance to resolve this peacefully since you said Darnell Williford was your friend. Christopher Berry then walked out the (over)

door and slammed it behind him threatening to go up to the Dr. King Jr. Center to shoot Darnell Williford.

16. After about five minutes of Terry Jackson thinking about what Christopher Berry said about going into the community center and shooting Darnell Williford and Terry Jackson sharing with his girl friend (at the time), Terry Jackson then jumped out of bed and rushed to get fully clothed and told his girlfriend Barbara Wilson (Nee Carodine) at the time, that he was going up to the community center to try to warn Darnell Williford of what Christopher Berry just said and try to defuse this conflict between Darnell Williford and Christopher Berry once and for all.

17. On April 29, 1991 Terry Jackson went into the Dr. King Jr. community center to try to persuade and convince Darnell Williford to give Christopher Berry and his group back the drugs he had taken or agree at least agree to pay him back for the drugs. Darnell Williford decline to compromise on giving the drugs back or paying Christopher Berry anything. Terry Jackson at that point informed Darnell Williford that if he wasn't willing to compromise with Christopher Berry about giving him the drugs back or paying him for them to defuse the conflict between them. Terry Jackson, then suggested to Darnell Williford not to go outside and confront Christopher Berry and told him to just slip out the back door and go home. Darnell Williford appeared to be listening to my advice until he let "P-Dog" (Patrick Clemmer) convinced Darnell Williford to go outside and confront Christopher Berry by telling Darnell Williford he had his back, but when Darnell listen to "P-Dog" (Patrick Clemmer) advice and went outside to confront Christopher Berry and got shot, "P-Dog" (Patrick Clemmer) ran in the front door of the community center and locked the door leaving Darnell Williford outside on the pavement dying.

18. Terrance Simpson was taken in custody April 29, 1991 for shooting Darnell Williford who at the time was 11 years of age, Christopher Berry was taken in custody

May 5, 1991 for being an accomplice with Terrance Simpson to commit this shooting.

Both Terrance Simpson and Christopher Berry lied and implicated me falsely in this crime they committed against Darnell Williford out of retaliation for Darnell Williford hitting and taking the drugs from Christopher Berry. These two along with a host of their friends conspired to lie and falsely implicate me in this crime falsely to try to save themselves from their own actions.

19. Christopher Berry, Terrance Simpson and a host of their friends Cornelious Hunter AKA "Red", Tavares Woods AKA "T-Bone", Antoine Robinson AKA "Bleach Face", Quincy Williams AKA "Q.V.", Eldridge Riley AKA "EB", Dante Cook and Leonard Herron AKA "Mookie" all conspiratorially falsified their statements against me to the Racine police department for their own personal gain they negotiated and compromised with the police to either hide their own involvement in this shooting of Darnell Williford or to negotiate a deal to prevent from being charge with some other crimes they **did** or to seek to be let out early from crimes they were incarcerated for already.

20. Confessions out of the mouth of the states own witnesses are Terrance Simpson, who said he was coerced and pressured into lying on Terry Jackson by the leading investigator Jon Soderberg. Terrance Simpson now has confessed to Wynn Collins who was a student at UW-Madison and worked with the Innocent Project in Wisconsin at the time and now works with Outagamie Prosecutor office in Wisconsin. Terrance Simpson is presently willing to come forth and let the truth be know before the court about him lying against Terry Jackson in this case.

21. Leonard Herron AKA "Mookie" in a interview with Racine Journal Times at the time with a woman by the name of Janine Anderson, Leonard Herron reported to Janine Anderson that he falsely lied on Terry Jackson in to the police and falsely implicated Terry Jackson at the request of Christopher Berry, because they thought Terry Jackson was talking to the police about their friends involved in this case. Leonard Herron also testified to this statement before Judge Gerald Ptacek before he provided this statement to news reporter Janine Anderson. Janine reported in her newspaper article the contents of what Leonard H-----

her newspaper article the contents of what Leonard Herron told her to the Racine Journal Times community newspaper December 14, 2009 (Monday).

22. Cornelious Hunter AKA "Red" in a interview with the same reporter Janine Anderson reported he told the police a falsified statement against Terry Jackson and testified falsely at Terry Jackson trial while knowingly knowing he was testifying falsely. Cornelious Hunter further stated, "He hoped police would give him a break in an unrelated juvenile case if he cooperated and verified the story the police wanted." This was also reported to Racine community through the Racine Journal Times News paper on December 14, 2009 (Monday).

23. Quincy Williams AKA "Q.V." also sent Terry Jackson a signed affidavit admitting that he lied on Terry Jackson in what he reported to the police and testified to (over) →

at Terry Jackson jury trial, which render Terry Jackson jury trial unfair because the jury was misled into convicting Terry Jackson based on these confessed lies by the state witnesses; Terry Jackson has maintain his innocence since he initially was falsely accused by these witnesses and charged by the state.

24. Terry Jackson also wrote the state prosecutor challenging them to provide him a polygraph test to verify that he is absolutely truthful when he says that he's **innocent**, and if he fails the polygraph test that he will discontinue contesting the conviction, that was proposed just to show the prosecutor how confident Terry Jackson is of his Innocence, but of course the prosecutor decline the offer.

Terry Jackson is writing a book titled "Framed A Murder" that's revealing all the obvious facts that reveal corruption in Jackson case by the prosecutor and police department; It also reveal evident and obvious lies that the state prosecutor witnesses testified to in trial including the head investigating police officer Jon Soderberg; The book is revealing malfeasance that were committing by public officials who had been sworn to uphold the law truthfully and honestly, but the book reveals contrary to their responsibility as public officials; Beginning with the state failure to reopen this case and investigate the confession of their witnesses against Terry Jackson for conspiratorially framing Terry Jackson for being involved in a crime that he had no involvement in committing;
