January 1st, 2017

I'm writing to you to inform you that today a guy by the name of Daniel Dirk #633088 cut his wrist with a finger nail clippers! He was on a hunger strike for 4 meals already and wasn't talking to staff and % Johnson still gave him a finger nail clippers and when she came to pick them up he refused to give them up and stated to her that he was going to use them to kill himself and she stated "No you won't" and "I don't care keep them" and over an hour and a half later while Rec was coming in an inmate saw inmate Dirk's cell window covered in blood and inmate Dirk passed out in a very big puddle of blood and the SGT came to his cell and wasted 10 min trying to get inmate Dirk to respond before calling HSU or a supervisor up to seg and over 30 min for the ambulance to be called! The staff don't do any kinds of counts during the day and they never take any inmate seriously when they proclaim that they're suicidal! You need to organize some more protests out front of GBCI! Also me and some other inmates will be going on a NO FOOD OR WATER HUNGER STRIKE very soon and would like you to send out mass emails to all Wisconsin News Outlets stating this to them on our ~~behave~~ behalf? Also could you send me the local field offices addresses here in Green Bay for NBC, CBS, Fox and ABC so, we can write them as well?

Peg can you please put my name and Doc# up onto any web pages like Facebook or ChristianMingle that you may have set up to reach out to the community for prayer and support through letters on this journey i'll be starting on Jan 8, 2017 and won't stop until they force feed me and ship me out of GBCI? Here's a bio of why i'll be going on my strike for you to put on those sites:

My name's Justin Lee Douglas#322852 and i'm a 34 yr old white male whose in prison at GBCI. I've had a hernia for over 18 months and have been steadily denied adequate pain medications! I've also been taken off all my anxiety medications and have been in seg for 16 months and i'm already a mentally ill inmate (MH2B) and being in segregations only making me worse! I'll be going onto a NO FOOD and NO WATER HUNGER STRIKE on Jan 8, 2017 until i either die or i'm transfered out of GBCI! I plead to all of you who read this to please pray for me and send any cards or letters to emotionally support me in my time of need so, that i know i'm not all alone (A.K.A. The Forgotten Man) my address is P.O. Box 19033, Green Bay, Wis 54307. Thank You Very Much For Your Support.
