2nd incarceration. Offense description; involved Burglary, Shoplifting, ^{3 COUNTS} Battery, 2nd Deg Sexual Assault and False Imprisonment with a ~~35~~ yr ~~7 DAY~~ sentence. Offense details include subject hitting his girlfriend in the eye and slapping her with an open hand, sexually assaulting her by biting her in the vaginal area and also refusing to let her leave his residence.

Statement on 12/16/2014: Randy Behnke stated that he did not wish to make a change to his last statement regarding his offense, which is as follows:

"I was drinking but I'm not going to use that as an excuse. I sexually assaulted my girlfriend by using physical force for a 12 hour period. That gave me the five charges. Being so drunk I didn't think I was forcing her but she saw it differently...I scared her."

Behnke stated to this worker that his participation in the voluntary program Truth Project has helped him with self-analysis and introspection and he made the following statement: "The Truth Project helped me realize that my lifestyle is what got me all this time. I've examined what made me, me. I take ownership of my past actions and my shortcomings and my problems."

Staff Appraisal and Recommendations (Pre-Hearing) Mr. Behnke received 25 minor and 6 major conduct reports since his 08/25/94 admission. He received no conduct reports since his last PRC hearing. He is on the waitlist for AODA and Pre-Release. He completed Anger Management, DVIP and Vocational- Data Entry, Optional, Office Software Apps, Optional. On 09/24/13, he was rejected by SO4 because he stated he does not remember sexually assaulting or attempting to sexually assault anyone. COMPAS risk level is low and his custody risk level is moderate. His PED is 08/02/16. His MR is 10/06/18 and his Max Discharge is 06/08/29. He is MH-0. He needs ECRB clearance. Due to his program needs, sentence structure, and ECRB status, it is respectfully requested he remain medium custody at RCI.

Inmate waived this scheduled review. This review was conducted pursuant to WI Administrative Code 302 and addresses custody, site placement and program assignments.

This is Mr Behnke's 2nd incarceration as a PV. He is a track 5 PMR inmate with 33 months to his MR date of 10/06/18. Parole Commission gave inmate a defer 11 with new PED of 08/02/16.

Program performance has been mixed. He completed DVC, Anger Mgmt and Vocational. He was rejected by SO-4 programming due to not remembering his offense. He is on the waiting list for AODA Residential and Pre-Release Curriculum. He does not meet ERP/CIP criteria due to excluded offense. Mental health code is MH-0. He does not require HSU on-site. Dental classification is 20. He needs ECRB clearance and SBN is undetermined. He has no SPN's. Conduct has been acceptable noting no conduct reports received in the past year. He rates moderate in sentence structure and temp factors due to the need for ECRB clearance. He rates low in the remaining areas of the risk rating scale.

The Committee's recommendation is for continued medium custody with retention at RCI. This decision is based on time remaining to MR, PMR status, D-11, Parole endorsement for SO-4 program entry and inmate begin rejected for programming.

A recall is set for 12 months based on sentence structure.

Inmate may request an Administrative Review of the Classification decision pursuant to DOC 302.18 by filing a current DOC-1292 Administrative Review of Re-Classification form within 10 days of receipt of the final decision. Administrative Reviews are based on erroneous information, not disagreement with custody and/or placement recommendation.
