Staff Appraisal and Recommendations (Pre-Hearing) Mr. Herrera has served just about sixteen years of his life sentence. Since admission he has been making improvements on his institutional adjustment. It has been eight years since his last major conduct report. He has received no additional conduct reports this reporting period. He is parole eligible in Dec 2029. He has had steady work history while being incarcerated. Mr. Herrera has no unmet program needs. He completed academic refresher and Vocational programming since he has been incarcerated. A COMPAS assessment will be completed with Mr. Herrera prior to his next PRC being completed and a case plan will be developed at that time as well. Social Worker recommends retention at medium/RCI. Recommendation is made based on seriousness of crime and time served compared to total sentence.

Committee Comments

No COMPAS assessment has been completed to date.

Inmate appeared for this scheduled review. This review was conducted pursuant to WI Administrative Code 302 and addresses custody, site placement and program assignments.

This is Mr Herrera's 1st incarceration as a new admission. Inmate is serving a Life Sentence. Parole Commission gave inmate a PED of 12/14/29.

Program performance has been good. He completed Vocational Optional and Academic refresher. He does not meet ERP/CIP criteria due to excluded offense. The Pre-Release Curriculum tracking status is changed to "terminated no-fault." Due to a system wide change regarding how the pre-release curriculum/modules are delivered completion is no longer mandatory for all inmates. Inmates may continue to access pre-release material on as needed basis. Mental health code is MH-0. He does not require HSU on-site. Dental classification is 20. He does not require ECRB clearance or SBN. He has a SPN at CCI. Conduct has been acceptable noting no conduct reports received in the past year. He rates high in sentence structure and low in the remaining areas of the risk rating scale.

The Committee's recommendation is for continued medium custody with retention at RCI. This decision is based on Life Sentence, assaultive nature of offense and initial Parole eligibility in 2029.

A recall is set for 12 months based on sentence structure.

Inmate may request an Administrative Review of the Classification decision pursuant to DOC 302.18 by filing a current DOC-1292 Administrative Review of Re-Classification form within 10 days of receipt of the final decision. Administrative Reviews are based on erroneous information, not disagreement with custody and/or placement recommendation.
