Dear Peg,


So how are you doing, i hope you're doing good? I'm doing about as bad as anyone could be doing! I've been telling psychological staff for 3 to 4 months now that i'm on the brink of either overdosing, cutting or hanging myself and never once did they have my cell searched to see if i had hoarded any of my sleeping pills, had anything sharp to cut my wrists or a noose to hang myself and on Wed the 11<sup>th</sup> i wrote my psychologist and told her if she doesn't have my one-on-one on Friday the 13<sup>th</sup> that i'd be dead by Monday the 16<sup>th</sup> and she never saw me or sent anyone to check on me and i ended up overdosing on Sunday the 15<sup>th</sup> and punching a officer in the face!

Now they've got a very unstable mentally ill inmate in a seg cell (618) that's got a big hole in the ceiling where an old fire sprinkle was and is very easy to knot a sheet up and hang myself from there! I've wrote to the Warden, Deputy Warden, Security Director and Psychological Staff and told them that if i'm not moved by 1-20-17 they'll be responsible for whatever happens to me! And if i'm not move i'll be probably dead as i've got suicidal thoughts every 2 to 3 days!

I hope that you're feeling much better? I'm doing worse than ever! I got the card that you sent to me as well as the manual so, i thank you very much for both of these things  
Peg...

I'd love to join you in any class action so please do inform me of what you need me to do on my end? What's this Doc overreach on act 355-? I've never heard of this?

I'm familiar with writing up John Doe's and as soon as i hear back from you about this Doc overreach act 355- i'll be more than happy to write up a John Doe and send it off to wherever you need it to go?

My hunger strike went well until i overdosed on my sleeping pills and i was rushed to the hospital where they put an IV in my arm and had to place me in the ICU for 2 days due to an irregular heartbeat! But i'm starting over now that i'm back here on 1-29 and will do what y. said, which was drink water!

This prison doesn't like force feeding and i've y. to see them do it to anyone!? About how long c. the prison just sit by and watch somebody not eat?

I never got any letter from you with Jacobs address from IWOC?

So please send me this info as soon as you're able to?

I'll write up a letter for you to release to the media about our conditions and lack of treatment in Green Bay and send you a photo of me to go along with my story! That way you can type up my statement and download my photo to your home computer and send off emails to all of these news outlets that you've sent to me because I'm barely able to write you with the stamps that you send me alright.. So I'll put that letter together by Sunday the 29th and get it out to you..

Until Next Time, Please Take Care Of Yourself, Stay Strong, Stay Positive, Stay Focused, Smile And Please Write Me Back As Soon As You're Able To Peg?
