On or about August 13<sup>th</sup> 2012 I, Markus Evans, otherwise  
known as, "Marko" was sent to solitary for allegedly putting  
a correctional officer in the hospital. The above named  
allegations transpired at Green Bay Correctional Inst., which  
resulted in me being given 360 Days in solitary confine-  
ment. However, once I made it to the last 3 months of my  
360 Day disposition I was transferred to, Wisconsin Secure  
Program Facility where I'm currently incarcerated. Upon  
completing the final 3-months of my original disposition, I was  
placed on AC in Wisconsin Secure Program Facility in the  
year of 2013 for what transpired at Green Bay Correctional Inst. In  
the year of 2012, when I was 19 years of age.  
I have been here at Wisconsin Secure Program Facility since  
May 30<sup>th</sup> 2013, February 18<sup>th</sup> 2014 the criminal charges involved  
Battery By Prisoner) were "Dismissed" in Brown County. At which  
point I attempted to contact the Warden here at Wisconsin Secure  
Program Facility to request a transfer to a more convenient prison  
for my family and loved ones as well as me being taken off AC  
being that all evidence used to find me guilty on a shot. Conduct-  
ed Disposition and later placed me on AC, was all the same  
evidence taken into account before a judge in a court of law  
which was "dismissed", My efforts were to no avail. I attempted  
contact the Security Director here at W.S.P.I. and my  
efforts were to no avail. When I spoke to Cpt. Mason about the  
then the then unit manager of Alpha unit at W.S.P.I., now who  
which is retired, she audaciously concluded none of it  
matters so I was found guilty of the conduct-  
ed, and being in population as far as myself go, presents to  
of a risk for staff and others, and I should try to sign-  
for the H.R.O.P. = High Risk Offender Program in another year or  
and keep doing good. (Sigh)  
we be advised the High Risk Offender Program at W.S.P.I. is  
really the only avenue one has to get off of AC once placed



on AC. It also now consist of 12-months at the least to finish. It use to consist of 18-months to finish. It should be noted that one is prevented from moving forward for something as small as receiving a behavior log for speaking to loud to other inmates. Also at times a month or two is added without good reason. For Wisconsin Secure Program Facility to expect change out of a man when the overall ideal of W.S.P.F. is to provide enrollment into programs that are set in place here at W.S.P.F. for just that, yet select man are treated impartial behind whatever said allegations they may or may not have done. In result of W.S.P.F. employees being too emotionally invested in their job oppose to professional, we are denied enrollment into programs/ "High Risk Offender Program" that is essentially the only way for one to get off of AC or persevere at all for that matter. It's just no coherent order here at W.S.P.F., — simple...

Finally:

By the beginning of year 2016 I was finally allowed to get in the High Risk Offender Program, noted above. However, on or about October 3<sup>rd</sup> 2016 upon returning from rec., I put my hand up, once I reached my assigned cell which is a regular practice here at Wisconsin Secure Program Facility for correctional-officers to conduct a pat-search upon returning inmates to their cell and exiting. This particular day my personal-space was invaded, resulting in the correctional officer who did so ended up in the local Roscobol Hospital, being treated for his broken nose, I was placed on central status which consist of being placed in a cell in just boots, underwear, that is as for clothing. Something I only know as a (security matters) that was about a quarter inch<sup>1/2</sup> of dyed rubber, of about 7 feet long and about 2<sup>1/2</sup>-3 feet wide, no bedding, no hygiene, no shoes no reading materials or dental care products were allowed to me. An I was only given a counted out 12-sheets of toilet paper for each individual B-movement. Please keep in mind I am a 23 year old grown man not a 6-year old child, 12-sheets of toilet paper is nowhere near reasonable to constitute as a adequate amount of toilet paper for any grown man to clean himself effectively after he use the restroom. To make matters worse the cell I was placed in on "central status" was fully luminous 24/7 by extremely bright fluorescent lights to further deprive me of sleep,



and the constant gust of dry air exhausting from the ventilation system did not make matters more human or comfortable, especially when I was only in socks - n - underwear. This carried on, October 3<sup>rd</sup> 2016 - October 5<sup>th</sup> 2016.

I was now placed in cell 301 Alpha October 5<sup>th</sup> 2016 that was not like others. It had a "security trap" well known as "back of cell" it prevents contact of any kind with staff. I was expected to be on this said Security Precaution / non-punitive for all of 15-Days. However, it's been alleged that some<sup>one</sup> walked past and said something to me which at this very moment as I write this I am still being held on "Back of Cell; Cell" for who one allegedly stated to me. ~~On~~ or about October 28<sup>th</sup> 2016, so, I am now only allowed to use the phone off the ~~unit~~ unit - manage I believe appear my phone - call app, I'm not allowed to go outside, nor am I able to enroll in the H.R.O.P to get off AC, I've been told this treatment / placement is now indefinite, it's only reviewed every Tuesday by a "Multi-disciplinary team", and there is no set end date. Please note, I have not gotten into any trouble now since, October 2016. I'm still trying to figure out how do this not violate the equal protection clause in full, how is this not deliberate ~~independence~~? I think it's fair to raise these type of questions in my particular case, especially what's called a non-punitive being used as one, being reviewed by a multi-disciplinary team, in a sense this is a form of admission that there is no plane to allow me in population no time room by there being no set end date to this deleterious activity, bestowed upon me. I'm not even allowed to be present at these so called multi-disciplinary team meetings nor am I allowed to present a defense for myself behind this injustice activity to subvert in the name Wisconsin Secure Program facility go on about how they have the best interest of society, staff and others at heart, but how is that when they fail to realize the strong potential of long term solitary causing one detrimental anguish which can only make it hard for one to function upon they release to society or ~~pop~~ population. I currently remain on AC, Back of cell, cell # 324 Alpha unit. Thank you for your time and attention in this matter, I was greatly obliged.
