Enclosed please find an affidavit sworn to & written by myself (Jovan Williams). First & foremost I appreciate the envelopes and the last news letter dated July 2016. Since then I've spent approx. 125 days in clinical observation status. I have also been on paper & pen restriction but I am finally getting settled and realizing what's important. In the last news letter you sent was attached a affidavit template & instead of feeling that ~~we~~^{one} out I have discussed this issue with another inmate and we determined that we will write out our own affidavit regarding "Inadequate Mental Health Treatment". We are hoping that our affidavit can be used for a system change in the prison.

We are "2" of the hundreds that suffer Mental Illnesses in solitary confinement without "proper treatment!"

I've suffered from Isolation impact & I'm being punished for disorders that I've developed in the noisey stressful environment that I am in. The lack of mental health treatment has more than just an impact on my ^{psychological} ~~psych~~ being it has even gotten me outside criminal charges which is a threat to my freedom & future!

Let it be known that I continue to suffer financially and due to restitution & other debts, the funds that my family send me are being taken. This is the reason why my letter and affidavit is being sent along with my fellow inmate. Please consider this when you send out the next shipment of embossed envelopes. I will sure u

AFFIDAVIT of

Pursuant to 28 U.S.C. 1746

- I, Jovan Williams, pursuant to 28 U.S.C. 1746, Under penalty of perjury, do hereby attest that:
- 1) I make this affidavit based on my own personal knowledge, willfully, voluntarily, and truthfully, and will so testify in court.
 - 2) I've been at Green Bay Correctional Institution in the Restrictive Housing Unit for over a year.
 - 3) I do not get any Mental Health Treatment here at Green Bay Correctional Institution in the Restrictive Housing Unit.
 - 4) In the Restrictive Housing Unit at Green Bay Correctional Institution doesn't provide any programs nor give me any programs for my PTSD, & other diagnosis.
 - 5) My clinician do not see me nor do he give me any adequate Mental Health Treatment.
 - 6) The Officers has use Excessive Force on several different occasion when placing ~~me~~ forcing me into control status instead of placing me in Clinical Observation Status.
 - 7) The staff do not give me Law Library even that it's verified that I have deadlines.
 - 8) The Warden wont give me any help & failed to protect me for my safety.
 - 9) When in ~~clinician~~ Clinical Observation Status and staff be giving me things to harm myself with.
 - 10) I did over 100 days in Clinical Observation Status and still haven't been sent to (WRC) even when I request it verbally.
 - 11) I been on paper & sharp restriction although I have not abused them and this makes it very hard for me to file my complaints in a timely matter which consequently gets dismissed for failure to file on time.
 - 12) I've been getting punished and even gotten criminally charged for a result of my mental illnesses.

13) I filed my complaints and exhausted my administrative remedies for "lack of Mental Health Treatment" and nothing has been done about it.

14) I was prescribed medication due to my illnesses. It was discontinued after a suicide attempt. I've ask the doctor's if there were any alternative to receive my medication instead of discontinuing it completely and the answer was "No". After the discontinuing of my medication I have suffered from with-draw and abnormal behavior due to the fact that they completely discontinuation of my medication after me being on it for a long time.

15.) The harm developed from "lack of Mental Health Treatment" also effect's my ability to socialize & talk to my family and I suffer from lost of social skillz that ~~on~~ can affect my future as well.

16) This Solitary Confinement environment subjects me to serious risk of deterioration & destruction.

17) I have request Mental Health Treatment to PSU staff & also their PSU Superrisor on my own in witting, and verbally in the Restrictive Housing unit at Green Bay Correctional Institution and they still havent given me any "at all".
