Dear F.F.U.P.:

Enclosed please find a Affidavit sworn to and written by myself Luis C Granados Jr regarding INADEQUATE MENTAL HEALTH TREATMENT that is on going in G.B.C.I. segregation complex.

I've been in segregation here at GBCI since May of 2015, and ive been a M-762B inmate the entire time. While in seg ive requested several times for Mental Health Treatment and any programing that will help me cope with my stress, but there are no programs provided in seg due to the lack of Mental Health staff; (I was told by my assigned clinician). Ive been told that a Behavior Management Plan (BMP) would be made for me but when I mention it I get ignored or told "one will be made soon".

Since ive been in seg, ive developed a self-harm habit to cope with my stress, cause thats what i've been left with. And i tend to get punished for this and behaviors I developed in segregation. Im currently serving a 270 disciplinary time in seg and have not received any conduct reports since January, 8th, 17 and my P.S.U worker told me Ill probaly be in seg untill im released due to the attention ive brought to my self.

Ive already filed my administrative Remedies to ICRS about Inadaquate Mental Health treatment I understand this is state wide that there inmates in seg suffering due to Inadequate Mental Health treatment and solitary confinement and im willing to help aswell.

My affidavit is approved by me to be used in a class action and hopefully we can change this issue for the future. I understand this is not a guaranteed and im OK with that.

I respectfully request a response to notify ~~me~~ me that my letter and affidavit was received and if I can help or how I can help

Affidavit of Luis C Granados Jr

pursuant to 28 U.S.C. 1746

I, Luis C Granados Jr, pursuant to 28 U.S.C., 1746, under penalty of perjury do here attest that:

(1) I make this affidavit based on my own personal knowledge, willingly, voluntarily and truthfully, and will so testify in court.

(2) I am a prisoner/seriously mentally ill inmate who is currently housed in Green Bay Correctional Institution segregation complex.

(3) I am considered MH-2B with a diagnosis of severe depression, anti-social personality disorder, bipolar disorder, and several more.

(4) I have been housed in seg for approximately 2 years without Mental health treatment or a Behavior Management Plan which is a protocol for MH-2B inmates.

(5) Due to inadequate Mental Health issue I developed a habit of self-harm to cope with stress

(6) I've requested numerous times for any programs that would help me with depression, anger, DBT, and was not attended to.

(7) I filed 2 complaint on this issue and requested treatment but no change

(8) I am continuing to be housed in segregation which leaves ~~to~~ me to suffer from loud noise that hinders my sleep and subjects me to psychological harm

(9) P.S.U staff lack sufficient number of trained staff to identify and treat individual prisoners who suffer from mental disorders

(10) P.S.U lacks basic programs for the identification of prisoners with self-harm behavior,

(11) P.S.U. has failed to transfer me to a more appropriate facility for programming for my mental illness.

(12) P.S.U has failed numerous times to follow up with ~~prison~~ me although im known to have a mental health disorder.
