How are you, I pray all is well with you. As for me, I'm still going through hell in this hell hole trying to get justice for them officers almost taking my life. I received the self help complaint form for the 1983 Civil Suit, thank you, but that isn't what I needed because I'm at the end of my last suit, the ~~last~~ Complaint had been wrote already. But don't lean on it, I have some ^{one} else helping me. But I really do need you to help get what happened to me, being assaulted and almost killed by A officer here. And after the fact that I almost lost my life and I let P.S.U. Staff, and security know I fear for my life being in this Prison, but eight months after the incident I'm still being left in this Segregation building do to this administration being vindictive trying to put me in A ~~cell~~ cell I don't feel safe being in, so when I refuse to go I receive A Condukt report for refusing to leave Segregation. So please have everything I said to you put in the media because it will help me win my last suit and ~~force~~ force this prison to do ~~their~~ their job put me in A cell hall I feel safe, or send me to A other prison. Also I told my guy across the hall from me I will ask you too have his ordeal put in the media at the same time you have mine so it will help too shed light upon the corruption and staff misconduct going on in the prison system. On 5-5-2017 inmate Vandelle over #54153 was placed in observation status do being suicidal, while in observation two officers was passing out lunch trays and instead of giving inmate over A soft tray with A paper spoon, the officer failed to protect him and gave him A hard tray with A plastic spoon non observation status inmates receive. So inmate over not being in the right mind state, he refuse to give the tray and spoon to the officer who gave him the tray, so the ~~staff~~

flier call the Unit Sgt Beam, who is very unfit to be a
 (supervisor). So Sgt Beam ~~try to~~ tried to get him to
 give him the tray and spoon but he refused. So before
 Sgt walked away to get the Sgt Captian butt, inmate over
 said to Sgt. Beam he is going to cut his self with the
 spoon. Instead of following ~~protocol~~ ~~going~~
 protocol which is for staff to stand at a
 inmate door once the inmate tell staff he or she is
 suicidal staff protocol is to stand at the door to
 be sure the inmate dont harm their self, and then
 call it in on the radio for other staff to come and
 the inmate out of the cell and the inmate be
 placed in observation until he or she speak to
 SU staff. But Sgt Beam walked away from
 inmate over door, then inmate over cut
 his self with the broke spoon that the
 other officer gave him. That happend do to Sgt. Be
 failing to protect inmate over, and Sgt Beam
 deliberate indifference. So staff came with the Sgt
 captian butt to escort inmate over to the strip cage
 once the door had open inmate over kneeled so staff
 could put the shackle on his ankles, instead of the
 officer asking inmate over to spread his feet apart so
 he could put the leg shackle on, the officer was
 kicking his feet apart so he can put the shackle on
 then once Mr. over stood on his feet, Sgt Beam
 pushed Mr. over hard into the wall for no
 reason while Mr. over had in hand cuffs and
 leg-iron, also Sgt Beam was bending Mr. over
 wrist up for no reason, I had at my cell door window
 watching the whole incident. Inmate over ~~call~~ ~~u~~
 brought back to the same observation cell across
 the hall from me and was strapped down for 36-hou
 do to security and PSU staff being vindicty
 once PSU let Mr. over up he was placed on ob
 that's when he told me while he was being escorte
 to the strip cage, Sgt Beam told him didn't
 tell him to stop turning his head, then Sgt Beam
 ran inmate over head into the iron shelf where

the Clean Cloths are kept at the top end of the hall for
 when the shower Mr. over told me when
 Sgt. Beam ran his head into the shelf he had
 knocked out for A minute or two, staff
 had to hold him up until he came through, so peo-
 ple are not asking you to take my word, but I
 am asking you to go on line and look up Correction
 office at WCI, His full name is Joseph Beam
 (Joseph Beamhem) once you look him up, you'll
 see he has at least 15- to 20- lal- suits in on his
 for assault to inmates, and he also be sticking his
 fingers inside inmate But hole when they have
 to cut the inmate cloths off. But yet this is
 the guy this administration feel it fit to run
 the leg building where he violated so many
 inmates right. So please for the sake of
 very inmate at WCI, please look his name up
 on line and get the exact amount of times he
 have been sued or violated any inmate right.
 and have that also put in the media so once
 that happen, you have my situation, inmate over
 situation and Co/ Beamhem all put in the
 media at the same time that will put this prison
 under scrutiny, then the warden will be forced
 to change things around here, and move
 Beamhem out of leg before some else get hurt.
 I just want to let you know I love you as a
 good friend, and I appreciate everything you do
 for me and everyone. May god continue to bless
 you to keep doing what you do!
