Well, I write you again from the dungeons of Boscobel. The black hole that is Solitary Confinement, the HROP as staff call it.

many of us down here on Fox 707 had decided to peacefully protest the HROP program and the what seems like, endless Solitary Confinement. Some inmates had chose to peacefully protest by going on a Hunger Strike. They heard the one that was done in Waupun last year was pretty successful.

So about 9-10 people wrote to medical and informed medical of their intention, no food, limited water, no threats, no violence.

many of the issues here at Boscobel and the Solitary Confinement program are unfair, bias and are meant to punish not reform or help the inmate. Unit manager Blown runs Solitary Confinement program. He is the ex-gang coordinator here and has a really harsh outlook on inmates and how they should be treated.

Its not physically violent here. Its all mentally done. The pressure they put on inmates here with the HROP is overwhelming.

They have violated our first Amendment rights here by punishing inmates for peacefully protesting the conditions of Boscobel Solitary Confinement. A (Liberty Interest) and a lack of procedure process has accrued here. Inmates here were giving no notice of procedure process.

Solitary Confinement. INMATES LOSE earned time

Some inmates were taking from Foxrot  
Solitary Confinement, to Alpha with Solitary  
Confinement. Alpha with is really harsh and atypically  
treatment for some one that violated no rules here.  
Alpha is A Cell with in A Cell. NO window,  
A really small cell. When you are brought out of  
your cell you are hand-cuffed behind your back,  
tethered to the door and pushed to your knees to  
be shackled too.

with manager Brown punished inmates for  
peacefully demonstrating their first amendment right.  
this is (Significant Hardship) Caused by with  
manager Brown.

Prisons are not allowed to punish you for

complaining about prison conditions. with manager  
Brown has done just that. Other inmates were  
punished by losing their step status. HROP

takes about a year to do. A 3 step process.

Red - First phase takes 2 months, then yellow  
phase, & take 3 months to do, then the  
last phase is Green. takes about 7 months  
to finish.

So the inmates who weren't transferred to harsher  
conditions lost program status. Green got dropped

So the inmates who weren't transferred to harsher conditions lost program status. Green got dropped to yellow, yellows got dropped to red. & some inmates such as Robert Ward were taken out of program status all together. Robert Ward says he is in contact with you. I am not sure of this. But he will verify all I am telling you.

So unit manager Brown has violated all of our civil rights by punishing us for peaceably assemble ALSO Amendment VIII, cruel and unusual punishment. The inmates peacefully assembled, no violence occurred.

So none of these inmates want to or know how to push back & try to fight with manager Brown, the warden here is complacent and does not want to change the bias and corrupt system that has been built by unit manager brown, Gang Coordinator LT. Cichanowicz and unit manager Brian Kool.

They have built a system here of fear and control. You will be unjustly punished for any type of push back, any type of protest of their mentally controlled program. No due process, no notification of disciplinary sanctions. Just punished with out notice of violation. A mental punishment of fear & setbacks.

They make you fear any type of (standing up for yourself). I myself have 34 more months to go til I am released. I am so fed up with these people and their manipulation of the process and procedures of prisoners rights.

They are really putting people thru mental hardship here, than releasing us into society! We are almost surely doomed to fail. Do you want inmates released back into society after D.O.C has mentally abused and tortured them? Solitary confinement, no window, sensory deprivation, and hostility and anger towards authority and people in general.

Robert ward gets out in 18 months. He is angry and has a problem with authority. Unit manager

There are several people down here with me  
that are on Administrative Containment, that get  
out in a few years. They are not being prepared to  
successfully get out and do good. MR BROWN WANTS

## Recidivism.

MR. Boughton is the Warden here and he  
chooses to do nothing about what's going on here.

LT. Cichanowicz will write you up with a  
false Conduct report. You will be found guilty.  
Then Witz manager's Brian Kool and MR. Brown  
will have you seen for some type of Administrative  
Confinement hearing, where you will be found  
guilty.

You will be placed on AC status. Solitary  
Confinement. MR. Brown will now have full control  
of your mental faculties & your life in general.

This program and system is a farce. It's  
meant to look good on paper. But to be in it is a trap.  
I am being punished by not allowing me to enter  
the program, even after numerous attempts to  
join. MR. Brown is denying me access. NO  
program, NO release from Solitary Confinement.

And the mental aspect of it is, I put in  
request forms to join programs. I get NO return  
of request forms and I don't get to join program.  
This is to show me I am being punished. I better  
recognize MR. Brown's Power & Control. What he says  
and thinks is ultimate status. I am not to protest,  
or act out in any manner.

I will be punished by their system. But I will  
never hear it from their mouths or receive notice  
of punishment. It will just happen. This is mental

English. Significant Friendship.

Universal Declaration of Human Rights = (UDHR)
