

July 4, 2018

- ① On July 3rd Senator Lena Taylor's Office wrote me asking for a PHI med. file release form. Filled it out and sent it back to her with a letter letting her know that you are personally involved in both cases, and are able to speak for me when I am unable to...as well as Cary, my brother.
- ② In this letter I let her know that I would ask you to send her Office the entire packet (Big-Letter), that I just sent. I also thanked her for paying mind to you Ms. Peg. As we inmates really aren't taken seriously...
- ③ On July 4th, I asked Cary to send you money for the phone again cause CCI has yet to transfer the funds from my Savings Account to my Regular (spending) Account. It's been about two weeks now. Did not get to order much on canteen this two week period...good thing I have back-up food in my locker!
- ④ Sent for new prescription eyeglasses...order returned for insufficient funds. Still getting headaches from the incorrect prescription. Even the Bifocal prescription changed. My eyes have been diagnosed with Diabetic Retinopathy...explaining the Double-Vision from the 'Film' on the back of my left eye. Also the cataracts gives 'night-type-blindness' that has me keeping the lights on, even during the day.
- ⑤ The Double-Vision creates 'Dizziness', also contributing to my significant imbalance issues (Falls). My Diabetes is out of control and the C/O's have denied access to my Accucheck, because it is not on my WICS computer profile from HSU! Staff do not even open my door anymore for the Accucheck. Used to measure it cause the Diabetic meds just started cause severe dizziness. This is what caused the 1-12-18 fall that broke molar/crown and extraction of the remaining root.

⑥ On 1-12-18, C/O Thome-Hume refused for two hours to allow my Accucheck. I reported to Thome-Hume how I'd not eaten for 12-hrs and was feeling dizzy/faint, weak, etc. After the fall, hitting my face on the sink, falling to the floor, defecating myself, C/O Thome-Hume gave the Accucheck to me when I showed the broken tooth and crown in my hand.

⑦ Sgt. Berringer ordered me to HSU and authorized a shower cause of incontinence issue. HSU issued Tylenol III for pain. Upon return to the unit, Sgt. Berringer was on rounds. I asked C/O Thome-Hume if I could take a shower. He 'Stared' at me through the bubble window. Sgt. Berringer came to the shower and asked me if I'd asked Thome-Hume, I told him 'yes', he wouldn't reply. I asked the Sgt. if he wanted me to leave the shower. He told me to take my shower (Berringer).

⑧ C/O Thome-Hume came about an hour later issuing a Conduct Report for unassigned area, disobeying orders, etc...Major C/R. And took my statement. This was clearly Retalitory Animus as I'd just informed Thome-Hume that he is 'now a defendant' in Case No. 17-cv-1493 for ADA violations. Cap't. Bussie dismissed the C/R in full citing 'this is Bull-s__t!'

⑨ The fact is, I started my Glipizide for high Glucose Levels after not having to take it for 9-yrs. My health has deteriorated to the point where I cannot exercise and control diet because I must purchase canteen items. Gaining @50-lbs since the lumbar implants has caused my Ostioarthritic Knees to disuade movement, and having to go up/down stairs constantly exacerbates all painful, and untreated painful conditions diagnosed by Specialists. E.g. Fibromyalgia, Ostioarthritis, 5-Bulging Cervical Discs/Stenosis, two Torn Lumbar Discs (L1/L2-L5/S1) and Failed Lumbar Surgery, Symptomatic Hyperparathyroidism, Chronic Left Knee Pain, Bilateral Carpal-Tunnel Syndrome, Painful Diabetic Neuropathy (Moderate), Chronic Fatigue, Insomnia, Degenerative Joint Disorder, Diabetic Retinopathy, Double-Vision, Chronic Falls, ...

⑩ There are over 5 referrals to Dr. Choi's Pain Clinic since 2016 which have not been followed-up on unless a Court-Order is presented to CCI Staff. Chief Judge Griesbach has already denied the injunctive request because CCI HSU staff sent non-relevant medical

documents to the court, combined with what CCI staff told me regarding treatment and provisions for Handicap Accommodations that were LIES. The Court issued an Order in response to CCI's staff file omissions and lies told to this inmate, repeated to the court that resulted in the denial of injunctive relief.

11 So, now I have been denied over 200 state meals, gained over 45-lbs, become actively Diabetic, lost a molar/crown, acquired diabetic retinopathy, lost cognition, etc...

12 What is troubling is that in the 6-months in CCI, I have had 12-cellis. All but 1 was from seg. Three have threatened me because of incontinence issues (placing them at risk from washing-soiled clothes in communal sink), filed 3-PREA complaints against cellis-separated from all three, while CCI staff know I was sexually abused as a child causing PTSD and Battered By Prisoner in 2012 by Ryan Olson (child sex offender), and four cellis have stolen a total of \$350.00 of personal property while CCI Staff know of my physical/mental disabilities making me a vulnerable adult.

13 Jan. 6th, 2018 security asked the Physical Therapist to 'Evaluate' me for the stairs. He came to the Handicap/Elevator Unit that I was on, made me walk up/down stairs once and I was moved to a 'staired' Unit. In 2012 Case No. 12-cv-1178 was filed for Failure to protect from inmate Ryan Olson. In 2014 Case No. 14-cv-53 was filed for not being fed for 11-days because I could not navigate the stairs...had a "No-Stair" Restriction till returned to CCI on Dec. 6th, 2017.

14 From falls I have broken my left elbow requiring surgical repair, fell in cell tearing L5/S1 Disc-causing incontinence, and fell in cell breaking off left lower molar/crown-causing chewing issues creating headaches because I do NOT have any other lower molars on the lower left side. How much more did the court sentence this inmate to? Subjection to theft, beatings, sexual assault/harassment, Torture, Retaliation, Vexation??? Is this in the interest of justice or in the interests of staff validation for losing 2 civil actions?
