DEAR MRS. SWAN,

I AM WRITING THIS LETTER WITH THE HOPE THAT YOU AND YOUR COMMITTEE WILL APPROVE MY REQUEST FOR AN EARLY RELEASE.

I AM 79 YEARS OLD AND NOT IN THE BEST OF HEALTH AND WOULD LIKE TO SPEND THE REST OF MY LIFE WITH MY FAMILY. I HAVE COPD AND AM IN NEED OF A HIP AND KNEE REPLACEMENT DUE TO ARTHRITIS. I HAD HEART BYPASS SURGERY IN 1996 AND A STENT SEVERAL YEARS LATER. I AM ON SEVERAL MEDICATIONS FOR HIGH BLOOD PRESSURE, ACID REFLUX AND HIGH CHOLESTEROL. ONE OF MY BIGGEST CONCERNS AT THE PRESENT TIME IS WITH THE LOSS OF SOCIAL SECURITY, MY WIFE HAS BEEN STRUGGLING FINANCIALLY. MY WIFE IS 75 YEARS OLD.

I HAVE BEEN INCARCERATED NOW FOR A LITTLE OVER 4 YEARS NOW AND DO NOT CONSIDER MYSELF A THREAT TO SOCIETY. I HAVE SERVED FOUR YEARS IN THE U.S. AIR FORCE AND EIGHT YEARS AS A VOLUNTEER FIREFIGHTER/EMT, AND FIVE YEARS WITH THE AMERICAN RED CROSS AS AN FIRST AID/CPR INSTRUCTOR. I ALSO COACHED LITTLE LEAGUE BASEBALL FOR THREE YEARS.

I WILL DO WHATEVER IT TAKES TO BE PROCEEDED AT THIS TIME. THANK YOU FOR YOUR CONSIDERATION.
