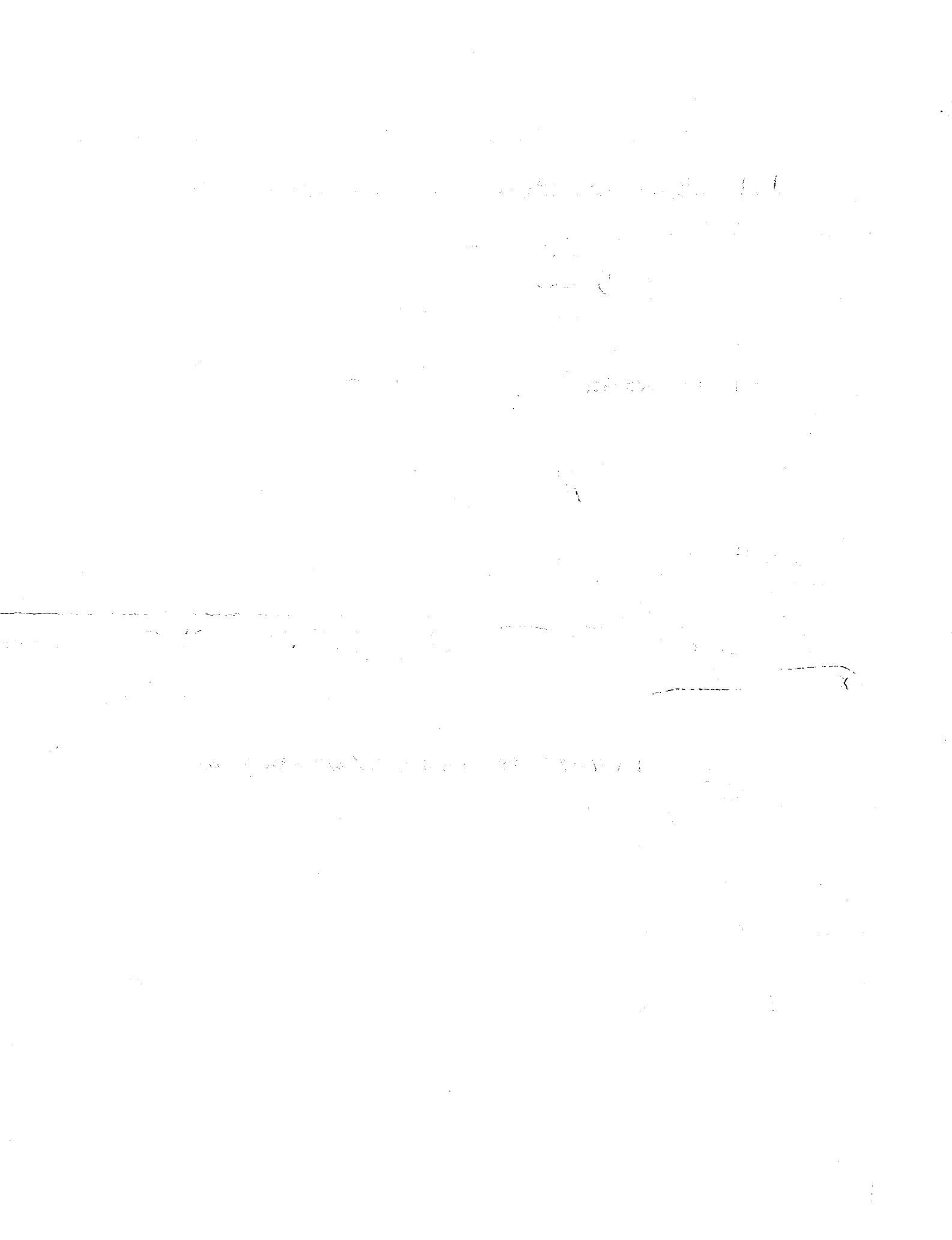

Due to the concerns of the seriousness of the Pandemic inmates safety is at risk because the employees come from the outside community it is a great possibility that I can receive covid-19 or other inmates as well. We receive one bar of soap per week no hand sanitizer or daily cleaning supplies only on Saturdays evenings. Between time inmates in staff practically touch everything such as door knobs, Door Traps, food Trays, in most of all not practicing social distancing which is six feet apart from each other. My unit was previously on lock down because a co. report to staff she was around a individual that was tested positive for covid-19 which she show alot of ~~symptoms~~ symptoms was noticeable around the unit the institution still allowed staff to come to work which any time you come into contact with a case where a individual tested positive for covid-19 should be Quarantine for at least 14 days until that person is cleared to contact other people.

1# This county has confirm cases of covid-19.

2# I interact with staff on a daily basis.

3# My safety is very much at risk due to not having no mask, or a pair of gloves, no sanitizer I have access to 1 bar of soap. My food is expose to several staff members we do not know who they was in contact with. Sooner or later this prison would be affected just like several other prisons around the country as well I would like to be treat like a Human-Being as well.
