11. **Description Of Crime And Circumstances:**


While I was in prison my then girlfriend had been on a regular basis using a sex toy on a 11yr. old girl. My involvement began when I became aware of her actions and began to have Deviant fantasies. As a result, I was alleged to have by telephone instructed girlfriend to use

the sexual toy on 11yr old girl in her care. My motivation for this was I have learned in Treatment that I was acting out on a deviant fantasy. Currently involved in several treatment Programs and have since completed many. Co-defendant and I were both tried and tried and convicted. I admitted my wrongs and took responsibility. This resulted in my guilty plea.

12. **Extradinary Circumstances That Warrants A Waiver of Governor's Eligibility Rule:**

Extradinary Circumstances are because my Vulnerable Medical conditions have been identified by the CDC that would warrant my Sentence Commutation. I am Approximately 3 years from release date. My conditions include type 2 diabetes, heart Disease, lung disease, (polyps on lungs and thyroid), thyroid disease, and a host of other Medical Conditions which fall into the the CDC's list of criteria for vulnerably adults age 50 & over. Especially those with type II (2) diabetes. Along with all of my other conditions makes me one of the most vulnerable. Covid-19 I am very susceptible to.
