This is Umma L. White a inmate housed in Robert E. Ellsworth Correctional Center. I am apart of the DOC News letter team & Lady with the WORT Family out of Madison WI. Aired on 89.9 FM Madison station.

My Reasoning for writing you; because of the struggle of living inside the walls of a prison with this Covid-19 pandemic. As I am sure others inside of the DOC contact you with their stories and tears. I am one of those inmates that fear of losing my life to this invisible enemy. I am a mother of 2; with my oldest age 14 and my youngest not make it home. I fear I may not make it home. I have 12 months left and it's for a misdemeanor case. I will be paroling home with extended supervision, May 22; of 2021 which is about 11 month or so and I've been threw a serious medical crisis. Since being in custody of the DOC I was injured while housed at Touchélan Correctional Center in Fond-du-lac.

The walking track was in terrible condition and I ended up injured. I was rushed to the emergency room and had a X-Ray done. The findings were a untreated back fracture that healed and caused me to have spondylolysis; Acute Sciatica; shortly afterwards, I ended up with blood clots & now as of April 13, 2020. Diagnosed with a enlargement in the left side of my heart. The doctor here is unsure of what the cause is and that scares me deeply; because he wants me to go out into the community to be seen which is great; but I then have to come back to the center and be locked away for 14 days with "no" phone or communication with the outside world like family & my fiance. Then the center here is "nt 100% clean. & w/o to par on the cleaning; the ventilation systems are terrible; the inmates are not clean; some people don't shower or clean and are not forced to. I've been told by my captain and superintendent that face masks are not ~~mandated~~ mandated so they don't have to wear

them or force their staff to wear  
 them. I've enclosed a request  
 form from the superintendent  
 here that stated this to me after  
 writing with the complaint. The  
 staff here pretend to care. The  
 Dnt. The staff had started to target  
 me for writing mental health  
 care doctor's with complaints  
 and writing the warden & even  
 sending out emails about the  
 craziness in Robert E. Ellsworth.

I've allowed the petty  
 conduct reports to flow in & the  
 eye rolling of staff. A staff  
 member stopping me to ask  
 how's the inmate complaints  
 going for you after reporting  
 staff misconduct on her. I've had  
 a captain sit me down with  
 a classification specialist to say  
 all of I was reviewing a conduct  
 report for going to the library  
 when not scheduled to after  
 being told by the librarian I had  
 library at that time. If I was  
 getting a ticket I shouldn't have  
 had to go to the captain's office  
 to speak with classification specialist  
 Sarah Mustonas. I feel that was  
 a way of telling me to watch

MUSEN. THE CONDUCT REPORT WAS  
"NO REASON" TO SEE A CAPTAIN LET  
ALONE A CLASSIFICATION SPECIALIST.

STILL I HOLD MY HEAD UP AND  
CONTINUE TO WRITE & E-MAIL  
THERE'S SOME JUSTICE IN THIS  
UNJUST PLACE AND SYSTEM. WE ALSO  
NO LONGER HAVE A SECURITY  
DIRECTOR BECAUSE HE QUIT AND  
WENT TO NISST IN MILWAUKEE.  
I WAS TOLD THIS BY A STAFF  
MEMBER AS WELL SO THERE'S A LOT  
THAT THEY WANT SILENCE ON &  
TRY TO MAKE IT SOUND GOOD  
WHEN WE'RE TREATED LIKE CRAP.

WE WENT WITHOUT WATER &  
HOT WATER AT THAT AND THAT HAS  
OPENED TWICE NOW. OUR  
WEST SIDE ONLY HAS ONE SHOWER  
BECAUSE THE OTHER BATHROOM  
FLOWED HIS MEDICAL. SO IT'S SHUT  
DOWN. THIS PLACE ONLY CARE'S  
ABOUT MONEY NOT THE LIFE'S OF  
THE INMATE'S OR PEOPLE IN THEIR CARE.
