The Crime I was convicted of is Party to a Crime; 2nd degree sexual assault of an Intoxicated Victim. On 4-21-06; I was led into an apartment (under false pretense); by Adam Askland, who according to the District Attorney had fled state while out on probation for a prior 1st degree sexual assault of the same victim & was brought back from South Dakota by warrant. I was brought into this apartment several hours after the assault on the premise of buying some marijuana. No DNA exists or was found implicating me in this Assault, & this is verified by Judge Benjamin Procter; & both the victim & leasee of the apartment both testified that neither of them had ever seen me before, & that I was not at this residence prior to, or during this assault by Adam Askland. Upon entering this apartment, I was forced to step over the semi-conscious nude Amy Yeager; at that time after yelling at Adam to get her out of the doorway, he proceeded to pick her up & drop her on the back of her head. Upon seeing this, I took Miss Yeager, picked her up & placed her on a mattress in the corner of this Studio apartment. The state has completely failed to meet its burden of proving Party to a Crime, & has illegally incarcerated me for a Crime I had no knowledge of or participation in. Aforementioned is the only evidence for this crime.

12. Explain the extraordinary circumstances that you believe warrant a waiver of the Governor's eligibility rules. For example, an extraordinary circumstance could be, but is not necessarily, the fact that the conviction prohibits you from obtaining specific employment. However, the desire to hunt or possess a firearm for hunting purposes does not constitute extraordinary circumstances.

Since my incarceration I have been exposed to & contracted Entrobacter, which is a very serious blood infection from drinking contaminated water with feces in it, as well as the reported (radium 226 + 228) for the past 14 yrs. What makes this extraordinary circumstances: On June 5, 05; I was hit on my motorcycle in Saugus Ma. as a result of that accident I crushed my skull, fractured my lung & damaged my neck & spine. Now, U.W. has had to cancel surgery twice due to my having contracted MRSA. I have a pinched sciatic nerve, & a deteriorating disc in my lower back, & 2 in my neck that must be removed, I can only walk a few hundred feet before I am forced to sit down. I am never going to be able to return to my trade of being a mechanic, which I have a degree in, & now 23 months & 3 weeks to release, my extended Release worker Ms. Kelly Laporek is holding my license hostage, saying she wants me to pay \$20,000. in overdue child support before she will allow me to drive. I have absolutely no points against my driving privilege; & more than likely, the only job I'll be able to perform is some sort of truck driving job. However, this conviction will stop me from getting any employment, that is, if I am lucky enough to survive the surgery. This conviction was retaliation for a sexual assault I was found not guilty of at trial in front of Judge Lisa K. Stark & an all female jury. It is more than clear I've been railroaded into this conviction. Meanwhile, the perpetrator Adam Askland; because he turned state's evidence on a perophile, cing he was involved in remains free, while I've been incarcerated.
