STOMACH PROBLEMS

I Just ~~was~~ Learned A person Here THAT WAS
in Segregation Had A Stroke WHILE He WAS
in Segregation ON QUARANTINE. I Bet BY THE
time they Found ~~He was~~ Him He WAS ALMOST
dead From the Stroke OR they Found Him dead
in Segregation. I Heard He Had His Stroke AND
WAS IN A COMA AND NEVER WOKE UP From the
~~stroke~~ stroke. I THINK WHAT they did Here

At OSHKASH they Found Him UNRESPONSIVE
got the AMBULANCE got Him out of there took
Him to the HOSPITAL ALREADY in A deep & deep
COMA AND LEFT HIM HOOKED UP ON MACHINES TO
KEEP HIS HEART going BUT I BET THEY KNEW
He WAS TOTALLY BRAIN DEAD RIGHT AWAY THEY HOOKED
HIM UP ON THOSE MACHINES TO MAKE IT LOOK
GOOD, I BET THEY ALL KNEW THERE WAS NO HOPE
FOR HIM.

I wonder How Long He LAYED in His cell
BEFORE they NOTICED something WAS VERY WRONG
WITH HIM.

I KNOW FOR SURE they will WATCH you die in
there, they will WATCH you die in there, I KNOW
THIS FOR SURE they will WATCH you die in there
they do NOT CARE, they HAVE NO CONSCIENCE
they don't HAVE the ABILITY in there BRAIN
to CARE ABOUT ANYTHING. LIKE THE LIGHT IS ON
AND THERE IS NOBODY HOME

I wonder WHEN they FINALLY Found Him IF
He WAS NOT ALREADY DEAD AND CALLED THE AMBULANCE
to COVER UP their neglect OF NOT CHECKING ON
HIM. He WAS 63 YEARS OLD. I KNOW HIM FROM
BEING in MY KNITTING CLASS He ALSO MADE HATS
SCARVES AND MITTENS FOR POOR CHILDREN. He SEEMED
to BE A OK PERSON, I REALLY DIDN'T KNOW HIM
TO WELL.

I ALMOST died in the Hole, Segregation
 They took me OFF OF ALL MY PHYSCO tropic
 medications AND MOST OF MY STOMACH medicine
 I took MY SEROQUEL AT A VERY HIGH dose FOR 23
 YEARS NOW STOP PLUS they took me OFF MY VALIUM
 AND MY GABIPENTEN ALSO A VERY HIGH dose FOR MANY
 YEARS.

BOTH DR TANNON + DR FAITH MY PHYSICIAN
 KNEW ALL MY medication WAS ALL COURT ORDERED
 I STILL AM VERY VERY ANGRY ABOUT THEM ignoring
 MY COURT ORDERED medication

Did I write to you ABOUT going to the WISCONSIN
 resource center? I mentioned it to a few
 doctors here but they are UNWILLING to SEND me
 there, I don't know WHY. I don't think they
 HAVE proper medical records ON ME OR they
 JUST don't want to HELP me. I think they just
 don't want to HELP me.

I WANT to get MY SEROQUEL, VALIUM AND
 GABIPENTIN returned to me. ALL those medications
 worked very well for me FOR MANY MANY YEARS.
 I WANT to go to the WISCONSIN resource center
 to get MY proper MENTAL HEALTH medication
 these people here are NOT HELPING me
 PLUS I would get a BRAND NEW medical doctor
 NO MORE DR TANNON. THIS idea is ALREADY
 MAKING me CALMER in side

THE SOCIAL WORKER JENNIFER DERINGER AND I THINK THE PSYCHOLOGIST DR ROBERTS HERE ON MY UNIT ARE AGAINST ME GETTING MY ERP. I WROTE TO YOU ABOUT WRITING TO THE PRC ERP PEOPLE SO I COULD GET MY ERP. DID YOU WRITE TO R MOHREN PRC PERSON HERE I JUST THOUGHT OF SOMETHING VERY IMPORTANT

THE PSYCHOLOGIST HERE DOCTOR ROBERTS SHE HAS THE POWER TO GET MY ERP AND ALSO CAN SEND ME TO A MINIMUM SO HERE AT OSHKOSH THERE IS A DACC PROGRAM ALCOHOL + DRUG PROGRAM I COULD GO THERE

THE WISCONSIN RESOURCE CENTER OFFERS A 9 MONTH ALCOHOL + DRUG PROGRAM I THINK THAT WOULD BE THE BEST PLACE TO GO. I JUST HAVE TO GET THERE

COULD YOU PLEASE WRITE A GOOD LETTER TO PSYCHOLOGIST DR ROBERTS, SHE SEEMS VERY NICE TELL HER EVERYTHING YOU CAN ABOUT MY STRUGGLES WITH ALCOHOL + DRUGS AND MY SERIOUS PROBLEMS WITH MY MENTAL HEALTH, MY MEDICATION ALL TAKEN AWAY, NO WONDER I AM SICK. LOVE ALWAYS
