also the B.C.E. (Badger State Enterprises) which does Laundry for all D.O.C. Connected Institutions, has had a confirmed Corona infected Bio hazard bag sent from W.R.C. (Wisconsin Resource Center) to O.S.C.I. to be ~~disinfected~~ disinfected and cleaned. Staff at B.C.E was notified via telephone/computer and warned that the bio bag was on its way, and to be prepared to correctly handle it?

have it and then State to the Public. cops Now too

in the prisons. So Public dont get more infected.


But they have no Problem Sending their infected Staff
