

Dear Mr. Reg,

A few quick things. I hope that you are remaining SAFE and Healthy. You are in my daily thoughts!

I wanted to let you know that we received notification today (Friday afternoon - after everyone went home for the weekend @ approx. 6:15 pm) that we Now have all been subjected to the COVID-19 at Green Bay Cor. Inst.

I AM NOW FREAKING OUT, and in severe Panic & Anxiety mode. We were told we are now on lockdown, and that a STAFF MEMBER has tested positive and that he was sent home. The officials are intentionally covering this situation up. They say that they don't know what happened here but they don't know who this is. They also say that they may not be able to reveal this. That the person hasn't been working here long. They don't believe the individual has worked on OUR unit (of which Health Services is located - no more than 5-10 feet from my cell).

Let me mention that if the individual hasn't worked here long - this person HAD to be around the institution and more likely than not has been to Health Services as I am under the understanding that you have possibly been to CBCT,

I know the housing situation. I am more vulnerable now than ever, with being openly exposed to it Now, after approx. 3 weeks ago, due to housing arrangements being changed. I'm even more exposed to All the sickness/illnesses from those who come to HSI as I now reside on the wing/side of which the inmate unit in the unit "dayroom" wanting to be seen.

Reduce my anxiety, as I write this (as well as fear), but we have had the Flu, H1N1, Chickenpox, and Now COVID-19 exposure. I believe I have shared my medical concerns of Asymptomatic Heart Condition, and my HIV (+) status. The officials have also placed inmates who have CPAP machines on the same unit/wing as me. More possibly being exposed to the COVID-19 in the GP call/halls and Deans!

However, these concerns are now even caused more grave concerns. That being that these possible exposed inmates use CPAP machines that could transmit the unknown COVID-19 into the air via these machines, & expose me to further risks. Too, added, that staff have been turning on the hallway fans & exposing me to further harm.

CBCT - IS NOT built to handle a

PANDEMIC, or ~~but~~ alone, a world-wide crisis as such. I am a greater - to the extreme, sick due that 1) a weaker immune system; and 2) I have been diagnosed as ANEMIC (since being at EBET originated from Vancouver and my iron has been very low. I was recently started on iron supplement after originally being denied for over a month & a half.

I also want to state that I have been taken off my depression meds (since Oct. 2018) and have been severely depressed, self-harming while here at EBET, and suicidal at times & several other issues of instability.

But currently, I am very concerned about my health, frustrated, stressed, increased anxiety and fear my safety.

Too, I'm also not aware that I informed you that 2 officials (K. Schierland, and another CO whose name is something like Scooter/Secoten) that work at both EBET and WCI. And WCI was exposed to COVID-19 several weeks back. While Schierland has worked on my housing unit frequently, the other officer has worked here on 2 prior occasions as well. All of which issue I have raised with Warden Kettle in concern to the then possible exposure to COVID-19. COVID-19 is finally here to kill us - and YES the staff has placed us all at greater

risk. Yet, they are here to maintain our health & safety? And they are innocent & do not place us in DANGER, daily? They need to be held accountable, just as we are. Is it okay for them to intentionally inflict such pain & suffering to us and our families? No we deserve a life sentence in place of being relocated because our Probation Agent doesn't want to help us in the community - in getting our life together... and we take action in our own hands to resolve legal endeavors?

I don't expect you to consider these questions. I'm venting my frustration, the wrongs of which I'm forced to endure. Share this via newsletter! Send to the Governor, and President - we don't matter! Why should Michael Cohen receive such special "release" treatment & not US with serious medical conditions?

We need JUSTICE! Who are the REAL criminals at most? Holly Zindall who worked at the Columbia Corr. Inst. as a kitchen worker (prison official) was the accomplice of 2 inmates who escaped last week. I have been placed at risk to STD's by other staff due to Sexual Assaults (9 occasions at WCI), and treated worse than a neglected animal. When is the line drawn & when does it end? When I'm dead with COVID-19 & the worst criminals (PRISON ~~GUARDS~~ GUARDS)

are set free?

Thank you for All you do and continue to do.

In closing, I looked up to see the message reading across the bottom of the screen on Fox II stating that the lawsuit filed by the ACLU and that the Wisconsin Supreme Court refuses to hear the lawsuit releasing inmates most vulnerable to COVID-19. THAT'S BULLSHIT!!

How can Illinois release 1200 inmates due to the exact issue.
