Dear Mrs. Swan,

My name is Aaron Antonio Allen. I'm 52 years old & I'm presently incarcerated at Columbia Correctional Inst. I've been in prison for 25 years for an armed robbery charge. I have 2 1/2 years to go before my mandatory release.

Mrs. Swan I need your help, or anyone who is able to help me ASAP! I've been fighting a false & bogus drug case here in Portage County for 7 years. In February of 2013 a white shirt by the name of Captain Chad Keller accused me of possessing four balloons that contained marijuana. He stated I got the balloons in off a visit. Here's the problem it's all a blatant lie that every bit of paperwork proves!! Captain Keller along with Sheriff Michael Hawerley of the Columbia Sheriff Dept. has "attempted" to make a case to cover up the fact that Sheriff Michael Hawerley illegally arrested & had my wife, Jaita Hawthorne, illegally cavity searched at Divine Savior Hospital without a warrant or probable cause. Mrs. Hawthorne was arrested on Sept. 18 & held for two (2) days & then released without seeing a judge, court commissioner, lawyer, or given any type of bail or signature recognice! She was arrested while trying to visit me on Sept. 18, 2013.

No drugs or contraband was found on Mrs. Hawthorne, nor in her car. Please keep in mind that Captain Keller alleged that Mrs. Hawthorne supposedly bought me drugs on February 1, 2013. Captain Keller & I had bumped heads previously because

I called them (staff) racist & liars due to a staff member lying about I bumped into her. I'm not one to use "racist" lightly, & by no means are all the staff at CCI racist. In fact, there are very decent guards here at CCI: Chad Kalka, Capt. Morgan, Lucas Weber, & C.O. Nelson aren't decent at all, & inmates & staff turned it.

Ms. Swan, I was charged with possession with intent to deliver in Columbia County in 2014 April, even though I was never seen with, nor found in possession of any drugs or balloons! My cellmate who was known for having dirty urine tests was found with balloons on his person during a strip search & a pat search, & never once did he implicate me in his mess. In fact, he signed a statement denying as much. Sheriff Hawthorn has lied under oath in a sworn affidavit in order to get my DNA & say it was found on one of the balloons in August of 2015. I have all the sworn CCI records involving this case & the D.A., Crystal Jong, was given a copy of the record & has allowed the Sheriff to lie under oath about the balloons being found during a cell search of my cell, & about a guard saying he witnessed Ms. Hawthorn give me contraband on our visit. The Sheriff further lied & said "he observed" documentation stating that Ms. Swan "No such paper work exist, or ever existed." I've had 7 lawyers who all refused to challenge & expose the Sheriff. I've written the Judge (Judge Veigt) several letters about the matter & all of my pleas have fallen on deaf ears!

Ms. Swan, I am being open & honest with you when I say "I'm being railroaded" by the D.A. & Sheriff in the attempt to avoid a costly law suit, & it's all in black & white.

My case has been in Portage papers several times, & my case is the longest on the court's docket. I've been fighting & fighting this case for years! Please help me shed some light on this issue.

MS. Hawthorne's case was dismissed with prejudice in 2017, & my case was dismissed as well. But charges were reissued against me again in 2017. I have been denied medium custody & parole because of this on going lie. I've attempted to contact news outlets & reporters. I provided news reporter Jaime Perez with all the necessary paperwork needed to show & prove all I've said, & her response was that "she don't know who's telling the truth". I'm still baffled by that. YMS. Swan please help me, or point me in the right direction. This is wrong on every level, & what I find so hard to believe is that I have proof in writing showing the lies. CCI staff has even come to court & sworn under oath that I was never seen with, never found in possession of, or even on the unit when my cellmate, Travis Solomon, was found in possession of drugs. Solomon has NEVER been charged with anything at all!!!

I have every proof to show the lies & set up! Please help me! I even have proof of the Sheriff lying to the DNA Analyst! Please contact me here at CCI, or my wife at 414-526-6608 Lorita Hawthorne, or my dad at 414-236-6278. If you can, please help me!?!?
