Hello how have you been doing? I hope all is well w/ you. And your health is in the best position. Especially w/ this covid 19 going on. I have a situation and was hoping that you can call here to help get the assistance I need. I was staffed in Dodge and the lady who staffed me Mrs. Potts. Said once the open case was resolved and I proven not guilty I was to put in the early recall to reclassification hearing. And the programs she put as needs she noted were to be taken off as needs. Cause she only added them due to the battery car charge. And w/ not guilty verdict in trial as was the case. She even noted that I completed all of the programs even in MSBF so it was no need to repeat same programs. Well I was not guilty in trial. I filed for early recall to PRC under grounds of substantial change in custody levels. Im low in every level of custody. PRC was to remove program needs and approve transfer to work release. The social worker Ms Shroader on R unit never turned in my request to early recall. For approx 3 mos she told me different things on status v/ dates of request. I was moved to unit E w/ new social worker. And she said PRC coordinator said they never had request for me. And to put 1 in. This means Shroader lied & really never did it. I waited approx 1 mo. To be told they denied early recall keeping schedule w/ it in Oct 2020. And programs avail. here. This violate my due process. PRC is to reclassify me w/ a substantial change as I did get. They just granted this for a few white inmates w/ no real change to custody. Then they offer me SUB (substance abuse) program as a counter option. Which if I was allowed PRC hearing they have it noted I've done and its to be removed off as a need of mines & Im to go to work release. The only reason Dodge court couldnt at the time was cause I had a detainer due to open case. I have 8 mos left in prison they wish to fast track me into these programs to get grant money and since Im short time its to fast

track me into what ever program that benefit them. When working to save money for release help me. So I refused it they taken my state pay as well as I'm denied a job for 90 days. When had they allowed me reclassification I was to be exonerated from program needs I've already completed.

Also I was hoping that you can look up and send me info (addresses) to places that offer correspondance help/mentoring w/ sexual abuse and sexual addictions. I have porn, sexual addictions to fetishes etc. I wish to get help w/ while here. I release to milwaukee wish for referral places there or in surrounding areas.
