

The rent for a Nasty environment 740 per month, NO support for reentering fully into the community by Nov. 1st, 2016 and No place to live while confused where to go with my boxes of paper work and the only clothes available, plus they made sure their cost of supervision was paid for 12 months, also the buisness "inmate-accounts person removed money from my account to pay citations at Butler to avoid being booked in Waukesha Co. upon Release from (M.S.C.C) milw. DOC. So my first P.O. Never knew I had <sup>to my head</sup> an injury and I still worked inside that facility doing maintenance work. Sorry I stop at this moment and I'll be sure to mail another a  GOD BLESS

I've been with a documented Brain tumor that I hadn't had my proof of it till intake here <sup>when I kinda started to wake up,</sup> 9-24-19, so I was staffed here for diagnostic testing to diagnosis and recommendations; but being I came from Columbia Correctional Inst. ILL for almost two-years! I was assaulted 10 times, even during staging for hearings I was unaware of the reasons to be taken at-vantage of! I don't revoke myself from probation, so →

I would become accepting to things I read! I was with the Not guilty by Reason of insanity (mental), defects and the spurts of partial ability have now I look, and read my first public defender said in a letter she wrote to me saying "health -  
- Records arrived <sup>"you"</sup> I requested and she said she "paid them";  
- then she doesn't <sup>"I don't"</sup> need them for me to know she's "bringing them to me". Well, she tells me by phone, correspondence, "while I was able to stretch more <sup>outside of a cell</sup>, but I tried telling her I was sick! She didn't understand anything, except <sup>"I read"</sup> some-  
- how my head was split needing staples, but she was un-  
- willing to look with me of the contents I didn't remember I had gone through I needed to have a friend or relative assist me and no one knew I was there in Ozaukee, Milw. Co. Jail for a while, but they distanced themselves, because they didn't understand the seriousness! I was having trouble reading, writing and the things staff put me through at the same time I couldn't get the help I needed! The Probation Officers I had never understood the things that paralyzed me at any encounter as they only needed to read that I was initially hurt at my street job in the Community of Grafton, then we, just a handful of us worked at a parts manufacturer being I was with years of work experience, some college to show here that the D.O.C. work release center were <sup>"not"</sup> even equipt. to help me the way I needed; only to be shuffled around <sup>by</sup>, every attorney I had was the same thing - Attorneys said they couldn't communicate with me!  
From the day I got to Dodge <sup>"from Revocation on 05/09/2014 cases ready to expire"</sup> from all I had from reading was  
(3) Non-Violent <sup>extra doc supervised</sup> ES-time ~~to~~ do, but my time was miss calculated

ON insufficient amount of Jail credit that was due to me from waiting at milwco. Jail  
then MSDJE just waiting in 2009 if I would be accepted into the MICA oshkosh (ATR) program being  
Dual Diagnosed back then <sup>2010</sup> out somewhere I never filed any motions to modify for early release on  
MSDF also got into 12 month program (ATR) <sup>2010</sup> <sup>circumstances used 2017 case Judge ordered consec.</sup>
