jusst wanted to send you this information in case you didn't
know about any of this.

It seems the elderly or the hadicap wiscosin realy doesn't care
about us. It has been said that the prisons in Wiccosin is an
indusrty . And every thing we buy from the property catalogs
is three times what people pay for items on the street for
example a TV costs 185.00 - 200.00 at J. L. Marcus
in Milwaukee but if you would buy on there it coast you
about 40 to 50 dollers and every thing in the catalog is
3 x as higher than in a regular store why because the DOC
gets kick backs !.

I don't know if Govenor Ever even knows about this
not only does it hurt us but it hurts the families that trys
to help us!.

I am having prablems with the Psycholgical Sevices
(PSU) for my PTSD Due to my childhood trama I was sexualy
assalted from the age of 5 and deal with night mares flash
backs etc. Any way I put in a request and they send work sheets
and tell me I'll see you in three weeks when I realy need to
see some one and not have to wait three weeks I should be working
withe some one on a set scheadual I realy don't get very good
help with PTSD Trama .

Even with Medical they'll tell me (us) that we can't aford it
it coasts tomuh so they'll take that medication a way. Like they
did one elderly Inmate and He has Copd real bad he told me that
he only has 5 months before he gets out but he's been so sick
he doesn't now if he will live that long. And this Gentleman
Is 78 years old and has a elderly wife waiting for him at home.
And if we send a request to the Doctor but the Nurses inercept
the requests written to the doctor. And when I ask the Doctor
about it she didn't know about she never seen them.

we have no say about any medical procedure they do what they
want we are like lab rats to them!.

There needs to be a change to this policy we are humanbeings
too but we are not treated like we are! we are the property
of the DOC and the state of Wiconsin there for they can pretty
much do what they want with us is there additude.

And also because I'm under the old law and because I have so much time they are refusing SOT programs and I have not refused any programs I have no conduct reports or tickets. In the 26 years I have been incarcerated in all these years I've never been in trouble in any prison. But parole doesn't take that in consideration. All we mean to the state of Wisconsin is that all we mean to the D.O.C. is money if the Federal government would cut back or tighten the purse string there wouldn't any incentive to sentence us for long prison terms. The Federal government is complaining about the over crowding in Wisconsin and other states as well back in 1960's or 70's the Fed's came into the Wisconsin prisons and cleaned them out they went through files and released prisoners and also reduced there sentences. The Fed's need to do something like that again!

the county jails are overflowing and so is the intake at Dodge Correctional Intake!.
