Dear Peg,

Thank you for your recent note. I appreciate the updates. I am glad to hear that you are doing okay and remaining safe.

As for myself, I'm not sure that I told you that I have been in RHL (Restrictive Housing) on & off since April 29th. Although, I have been back in it for a month now... and trying very hard to keep it that way.

I'm sorry that I have not written much, but as you may know - these pencils in RHL are useless & hard to write with. I choose to write as little as I can when I'm forced to use them.

So much has gone on here, and I am playing hell on trying to catch up with everything. I have a million and one things to get done and I am so far behind. I actually have a couple of updates, and information from you that I have been trying to get done, but as always, there are more things being thrown at me (us) all the time. Being that I received another note from you last week, I thought I would touch base with you right away. There is so much to tell you, but need to keep it short as I have a couple of deadlines to meet this week. However, I do plan to write more once I'm done with these.

The latest issue is that we are having a 2nd wave of COVID-19 at the moment. The Wis. National Guards came back last week as we had approx. 50-something cases. I just got my results back today which was negative. I'm trying to stay positive about the current situation. It really wears on the mental state of one being locked down & everything is being taken from us.

As for Terry Saeny, I know he had underlined medical issues, but I was on the same unit as he before going to seg on April 29th. My opinion is that he seemed to be focused on possible release on Parole,

as he had been working on. His health seemed fair to me without any current problems. I wanted to mention that I went to PH a 2nd time a week after released and I was upset. I raised the issue that I felt the Medical & Security staff murdered Jerry. The Whitehouse's response was: "No, the hospital might have said that (meaning he died of COVID-19) to make it look good." For several days I called every officer a murderer!

That is my belief - yet we'll never know the truth! I believe that the prison officials killed him by not providing proper care & treatment. Seeing how they have ignored & overlooked some of my own medical issues - I have no reason to doubt otherwise. But I plan to write about him to other organizations, all as I feel it needs attention and hopefully an internal investigation. (I am hoping to have the medical doctor investigated for my own personal reasons - due to care.) I will keep you informed.

As for DFW, I have been in contact with Mr. Seukup, and have had several hour-long phone calls with him. I asked for help regarding my hearing aids, but long story short, he has really been useless. He closed my case the week before last, & has only sided with the medical department. I still have not received my 2 hearing aids in 1 1/2 weeks of being ordered & back order. I have a complaint to complete & return to PH as I am not satisfied with response in his letter since the last call 2 weeks ago. He has informed me several times that inmates have contacted PH (him) for help, and they just don't have the resources, or just can't help them at all. He informed me to contact ACH regarding COVID-19 release issues.

I also have received all 2020 Newsletter's from Coalition For Prisoner's Rights. There is a great deal of good information & regarding long-term solitary & COVID-19/ releases/ cut prison populations. I would suggest reading them at: www.realcostofprisons.org

I am also finishing up the "Waiver" to Home Depot
Evers. I did receive a "general" letter (response) re-
garding my letter to him that you forwarded. I'm
also working on a letter and also the "Standard
Executive Address Form" that I sent home to my
buddy for copies.

I will be in touch again soon. Thanks for all
your work. Please stay SAFE and healthy.
