which the 2nd one is a good read I am trying to find out who the workers are from the outside but we are not allowed to talk to them and they don't seem to be wearing anything that shows who they work for. but they should be the same company that referbished Waupun corr. inst. Which if you got a contact there ask him to tell you thje stories of when they leit that place up when they did this same thing over there with lighting toilet paper on fire and tossing it over the tears for when they had the newly done segregation toilet/sinks placed in their cells and the porclin ones taken out, and what a chanbge for the worst it has caused for the entire prison. I am trying to stop this but can only do so much form in here I have started soemthing for Tony Evers but waiting to send it out I got all those items see the forms included to show that I received them, buit the stamps are gone I used them on this letter to you, one to Jim, and one to Tony Evers, the other 2 had to file appeals to madison over two important agguements for my property and for my medical services that are being denied for personal matters.

UPDATE: Just in the National Guard is being called in they will be here either 08-18-2020 or by 08-20-2020 the latest. They are tests that are going to happen but am hoping that they take over the running of the prison to better protect us.

Well I just wanted to get this letter out to you get back to youir two and give you a little something different than jims to blog on which i have labeled each topic outlining that argueement for better informal ways of understanding better.

let me get to your 2 letters and than on to the next topic for the week. just wanted to let you know that I got everything and won't beable to write again for I am out of stamps. Peggy i just wanna thank you so much for the propoerty for better useage of informing the public on what goes on in here.

Thanks on the governor sheets that is better for me to get word to him when ever you can send me more copies would be great. also if you could make some copies of my new photo for me that would be great and if you can make copies of the other photo for me that i sent to you a while back I ask for these copies of everything for I am unable to get them done myself, and if I could take more pictures or copies of documents myself I would but due to lack of funding I am out of luck living off of .05 cents every two weeks.

Do you know who the new DAI Adminstrator is and it's cheif? Thanbk you for starting the blog and connecting it to the s advocacy also. I just got some stuff that will help in that in which the DOC is constintly getting away with and these legal things that i found shall put a stop to that if they are filed in the ways of appeals or ICE's or C.R.'s when they come about. Once I find them I will send them nextt time.

If anything you can contact the lead captain here that says he is trying to get my Hot-Pot back to me stating that I do infact have a hot-pot and that you bought it for me, i have the receipts to it and sent it to him and it really is my hot-pot but with out an outside influence on this issue they feel as long as it is not outside the prison making a fuss that they can makje the problem dissapear. the Captains name is William SWIEKATOWSKI so if at all its worth a shot the only number I got for the prison is as follows 920-432-4877 don't know if you can reach them here. I hear you on the letters to be bloged.

As for the toilets/sink units they sare the same kind they have in the segregation units that are all made of metal and all one unit set on a timer which is very unsanitary. I will try to get you a better picture of what I am talking about so you can understand or even drawe a phot of what they look like so you can scan that but what i am talking about is in the blog i just sent to jim so read that and let me know what you think.

I will condense it down to the factsa and leave out my opion if that is what you want but the opion of what i have to say

opens up the perspective of the facts and whats to follow if they are continued in their way of change in the direction they want instead of what is right. No my MH is zero and i have no diagnosis at all i am cleared 100% sain with no issues at all. mybe it's jsut dealing with this nonsense for over 15 years that my ranting is coming off as crazy iDK? but I will work better for the both of us to get what is needed out to the public. I unjderstand that dealing with thsoe in prison can be overwhelming and that most of thsoe in here only want to use another instaed of what is more important and that is helping not only yourself but others and you need to take thos ebreaks and if you need help in seeing who is using you and who needs the help in the change for the better I will send you soem ways of finding out who really needs you and who doesn't i will get soemthing together that you can use in your life and that you can blog tot hge public to better prepair them in the future and see if they themselves are being used in life from behind the walls for that is my biggest petpeeve when soemone is being used, accused, or abused. I will not stand for it and will fight till the end to protect those that are being a harmed in any of thsoe ways. You a graet woman and I appricate your help in helping me get what needs to used to get the word out there.

I know how help is work and I will make an effort to better prepair things for you so all you f gotta do is scan it and if so you want to see what i am talking about go ahead but just know my word to GOD i will never do anything to risk you or the public and will never use anyone.

As for the tablet i don't have it yet I hollared at my guy and he just said he doesn't even know if his mom ordered it so i am getting on his ass to see what the hold up is, I been paid him for nearly a year and now he needs to come though on his end.

But I will not send anything by email to you I understand that you got much work to do, Jim just seent me his personal addy so he said either or is fine to send thru emails or letters I jsut sent him a letter due to the shut down of the Kiosks.

Well i will get some mopre together for one of my old cellys are getting out soon and i will give him a manila envelope full of stuff for the post office to send to you if at all possible that way i can get all this other stuff that will better ultize you in the long run how the prison is being run in the rules you in the long run how the cell hall living rules to the DOC that they give us from the cell hall living rules to the DOC rule book that you cna keep I was working on a longer list on my CD in the library for you so i could just that but that has been shut down since March and I am nowhere nearly done on that so this will have to do for now.

I will get on that other subject now.

## \*CORONA VIRUS OUTBREAK AT GRRENBAY CORRECTIONAL INSTITUTION \*

On August 9th 2020 at the PM hours on the South-Cell-Hall of the prison the Covid struck, not by the prisoner but by the staff that are suppose to keep us all safe in here but failed to do even that by bringing in the Virus that is causing DEATH!

Was coming back from rec., when they told us to lock in. Little did I know that the Covid had already begun to start on the South Cell Hall of this prison. Not until the next day from an insider that i have gain my information of that the first case has begun, and it was brought in by the staff. Thje protocols set in placew to protect us the prisoners have been over looked due to staff being lazy. There is no other way for this Virus to gain access into this prison with the shut down of all contact with the outside. It is sad that staff is putting the lives of the innocent like us the prisoners at risk for their lack of job responsibilities. Further-more there has been many staff member's that joked about bringing in the Virus to infect as many of us as they can, another way to extend their "Crule and Unusal Punishment" against us without the outside eye to known the truth behind the actions taken against us in here. Which i have many storys' to share of the amount of evil they've conduct in here since 2009 when I was placed here.

So Lock-down of the prison was set in motion. This is an attept to stop the spread. The individual was taken to the treatment center a room to be placed in while the tests are going to make sure he is positive, and his celly taken as a back up to stop the spread if he too is infected.

Three days later it is August 12th 2020, they (STAFF) Did not stop the spread. Instead 27 more cases have popped up in those 3 days since the first prisoner has been struck with the Virus. Is this because of the prisoner interacting with one another? NO! We as prisoners have already been forced with social distanting by means of having us on very strict movement to nearly none at all. for 24/7 we been locked down in our cells with only movements to rec 2 times a week, to showers 3 times a week and to the Kiosk

2 times a week. Now that might seem like alot but it's not when in the time spent at thoose areas are as follows; Rec 45 mins, showers 6mins, Kiosk 5 mins. that is the time we are alotted to be in that area and time to have there. Now most of these are over-lapping times with one another. Like we'll have Kiosk and rec same day, showers and Kiosk same day, so all in reality we are only let out of our cell for a max of 2 hoursand 3 minutes. in a whole week that is, before the out break too. Now we haven't been to showers in 8 days and still there is no word if we will be able to get clean. Not until the 9th day when finally they allowed us to go to showers, and that was the first time we were let out of our cells, all in an effort to stop the spread but it is still spreading in the South and will continue untilk the staff are forced into more extreme measures in testing before they are aloud in the prison. They are killing us for we are forced to stay here we can not jsut get up and leave to a safe place thus they atre getting away with murder and it's not the first time I seen them get away with it.

Well 4 more days have gone by and still no more showers have gone on. the prisoners are getting wild and crazy for they want to bathe and be clean but staff still refuses to allow us our mandotory showers that we are allowed by law to be clean in a weeks time. Still the Virus sprads there is no stopping it on the south that is our ground zero. It is contain over there as long as the staff that work over there stay over there, but that is not the case a Sgt Llynole don't know his spelling of his name but it sounds like annoy with a L at the beginning. Well i see this Sgt. obver on the North Cell hall unit playing on the computer joking with his fellow staff members saying that it crazy over there and he is laughing stating "I hope all those FUCKERS! get it good riddings to erasing the scum of society." Now does this sound like someone who cares for our safety? I say NO!, but this is what we have to deal with as prisoners that our voices are cut off from the world that we are desprately trying to get back to any way that we can. You don't understand what we as prisoners have to go through everyday, noit just with ourselves, other prisoners but the staff that are suppose to protect us but we have to protect ourselves from them.

## The way a human is treated in segregation part 1

The way a human is made to live in the hole (segregation) is inhumane. The way of everything is just wrong and before I just unlaod a bunch of facts i will start off with the way we are made to eat.

We are forced to eat with these paper sppons as indicated in the photo included in this blog. Now why are we forced to eat with these paper spoons or if were lucky a rubber sppon that can not hold anything or even pick up the food. It is because of the treatmernt of the prisoner by staff, it is badf enough that we are taken away from everyone and everything that we own and forced to be subjected to nothing but nosie, isolation, and madness. There are many things put in place that allow us a little freedom from the madness that we are deemed to endour. But that is not always being done while your staying in the hole. So again i say why are we forced in eating with paper spoons. that is because of the mental and physical abuse that we are being treated with day in and day out from 3 different shifts from staff that most want to see how far they can go in making someone snap for to them it is boaring enough to watch inmates behind locked doors 24/7 and siting around doing nothing for 8 hours gets to the guards so they staff start up shit with us to make us snap on eachother down in the hole or on them so they staff can use physical force against us or make our stay in the hole a more remeberal one. Which I will get into in the other parts to this . But one day a prisoner had enough of the inhumane treatment towards himself and he sharpened his spoon a plastic one like you'd use at cook outs, or for a small child or baby, on a picni what every. With that newly sharpened spoon he cut himself over and over to get the attention of a Captain to talk to to show that he was being mistreated but nobody would listen. Now this inmate went in for maybe a loud raid radio but is now leaving with self/multalation on his records and with a new Mental health (MH) level and on medications that he never needed before. That is why we have to eat with paper spoons because of the treatment by staff. So to stop further harm towards any other that might do the same we are giving paper spoons that is impossible to eat with.
