HEADACHES, TIRED, FROM LACK OF NUTRITION WHICH IS
MAKING IT HARD FOR MY IMMUNE SYSTEM TO FIGHT HIV
AND IF I DON'T RECEIVE ADEQUATE NUTRITIONAL TREATMENT
MY IMMUNE SYSTEM WILL BE DESTROYED, I WILL CONTRACT
COVID-19 AND I WILL DIE, THE PRISON HEALTH SERVICE FABRICATE
MY MEDICAL RECORDS TO MAKE IT APPEAR THAT IM REFUSING
TREATMENT, BUT I CAN ASSURE YOU, THAT'S NOT THE CASE
