Dear FFUP,

It's been quite a while since I last wrote you Peg, specifically back in my days when I was at WCI. I went from there to WSPF after being part of Vasquez, et al., v. Braemer, et al., in 2012, which was a group lawsuit under joinder rule. We were allowed to proceed on our claims of 8th Amendment violations by subjecting us to conditions of confinement of Administrative Confinement that caused us to suffer serious physical and mental health problems. Ultimately, we lost our case on summary judgment despite and issue of material ^{fact} of being present. We appealed and lost.

Our case was talked about on WPR, Wisconsin Public Radio, and everything, but by being prisoners we lacked the resources to combat the DOC.

I went to RCI from WSPF for 5 years, then ~~was~~ security at RCI attempted to get me moved per lateral transfer, and PRC shot their request down. About (1) week later I was back in front of PRC due to a C.O. putting a SPN, Special Placement Need, on me claiming they feared for their safety. This was my 2nd retaliatory transfer I've experienced within the DOC during my bid. I was sent here to OSCI, which had already be dealing with an ~~active~~ active COVID-19 OUTBREAK!

I was tested by the National Guard at RCI, and my test was negative for COVID-19.

After I arrived here I was placed in quarantine for 14 days, and tested on the 10th day for COVID-19, and my test results were negative again for the 2nd time. I was released to G.P. on 8/10/20 and sent to the intake

dormitory/barracks housing unit. I was tested again by the National Guard at OSCI on 10/1/20 and my test results came back positive for COVID-19 on 10/3/20.

I never thought that i;d catch the coronavirus in prison! My family has been ~~distraught~~ distraught, and outright furious with the DOC! They've been contacting Madison, News Media outlets, to expose what's going on in here. I've written Action 2 WBAY-TV news station to expose what they ~~are~~ are doing ~~in~~ in here. They had over 60 positive cases of COVID-19 in this dorm, and have us quarantined on one side of this dorm. They've been putting new cases in with us that have been quarantined for 14 days as I speak. They just retested the negative inmates on the other side again to see if they are infected! A lot of of are still having symptoms of COVID after 14 days, and the UNIT MANAGER, KATHY SABEL, TOLD US THAT WE CANT GET REINFECTED PER HSU STAFF, BUT IT'S BEEN CONFIRMED ON TV THAT YOU CAN!

I'M IN THE PROCESS OF EXHAUSTING MY ADMINISTRATIVE REMEDIES BECAUSE I WASN'T SENT HERE TO CATCH A INFECTIOUS DEADLY DISEASE! THE ICRS HAS BEEN GIVING ME TROUBLE AS I ATTEMPT TO FILE MY COMPLAINTS ON THE CONDITIONS OF CONFINEMENT ON THIS DORMITORY! THEY ARE MAKING ME FILE INDIVIDUAL COMPLAINTS ON EACH HORRENDOUS CONDITION. THIS IS WRONG, AND CONDITIONS OF CONFINEMENT ISSUE FALLS UNDER THE TOTALITY OF CIRCUMSTANCES APPROACH CLEARLY! THEY ARE TRYING TO LIMIT MY COMPLAINT VOICE, AND DISCOURAGE ME FROM PURSUING THIS. WERE ONLY ALLOWED (1) COMPLAINT PER WEEK, BUT WHEN IT COME TO HEALTH AND SAFETY WE ARE EXEMPT FROM THIS RESTRICTION. THESE CONDITIONS PUT ME AT A RISK FOR REINFECTION CLEARLY.

PLEASE PUT ME ON YOUR MAILING LIST FOR THE FFUP REPORT/NEWSLETTER. DO YOU HAVE A EMAIL SO I CAN ADD YOU TO MY CORRLINKS ACCOUNT? I sent BEN TURK A INVITATION, BUT HE HASN'T ACCEPTED IT YET. IT'S ASHAMED OUT OF ALL THESE INMATES WHO'VE CONTRACTED COVID-19 the ~~lack~~ OF FIGHT TO COMBAT THESE PRISON OFFICIALS!
I LOOK FORWARD TO HEARING FROM YOU AND YOUR ORGANIZATION PEG!
