deny us things.


P.S. my interview form took 3 days to get answered?

On a separate note Reg. I do also like to plant this "Seed" idea, those D.O.C. officers Sgts, CO. II etc. all complain to Governor, etc, about Harsh working conditions Hostile environments? Hazards etc. ~~and~~ and that they need all this Xtra Pay to be able to tolerate their jobs? Reg. That's so much BS! They all Congregate in the blind spots from the many, many, cameras. Mostly. Behind Sgt desks areas in offices down at B.C.E (Formerly B.S.I) and offices at the Gym. at any given time you can find 4 to 8 officers and Sgts all Hidding out of camera view. Feet kicked up on desks + counters their backs to "all these Dangerous inmates and Conditions, etc. they are constantly eating + Drinking so they do not have to keep their Covid masks on."

Reg inmates are Monitored by cameras everywhere we go. Staff think they are all above this? they call playing "Grab ass" behind the Sgt desks on 2nd + 3rd shifts mostly. watching Porn on the Thumb drives they bring in from Home, some Reek of alcohol. When they come to work, etc. We need to get cameras to be monitoring the areas behind the Sgt Stations and in the offices. TRANSPARENCY. Our families should be able to access these cameras as well. Tax Payers are paying for them After all, if Staff know they are being monitored as well they would actually do their jobs and HAVE to be more honest but other incidents as well.
